

9. (Pacific Gas and Electric Company - Transmission Line over San Joaquin River to Rough and Ready Island - San Joaquin County - W.O. 232, P.R.C. 177) The Commission was informed that the Pacific Gas and Electric Company has applied for a right-of-way easement 100 feet in width across the San Joaquin River to Rough and Ready Island, San Joaquin County and 260 feet in length for the purpose of suspending, maintaining and using wires and cables for transmission of electric power. On March 30, 1945 preliminary permission was granted for this crossing pending formal application and subject to approval by the Commission.

Upon motion duly made and unanimously carried, a resolution was adopted authorizing the Executive Officer to issue a fifteen year right-of-way easement with right of renewal for an additional ten years on such terms as may be determined, to Pacific Gas and Electric Company over the San Joaquin River to Rough and Ready Island, San Joaquin County, said easement to be 100 feet in width and 260 feet in length at an annual rental of \$45.20 from the effective date of March 30, 1945, no bond being required as there will be no structure on State land.

10. (Transfer of Jurisdiction of Tide and Submerged Lands in San Diego County to State Park Commission - Silver Strand - 138 acres - W.O. 220) The Commission was informed that at its regular meeting on October 17, 1946, the Commission authorized the transfer of jurisdiction over the 138 acres of filled tide and submerged lands involved in Condemnation Action 540-SD Civil to the State Park Commission subject to certain conditions. The area of 138 acres included all the area described in Condemnation Action No. 540-SD Civil. After the Commission action a field survey was completed showing the filled tidelands as having an area of 106.68 acres. The State Park Commission has requested clarification of the transfer of jurisdiction.

Upon motion duly made and unanimously carried, a resolution was adopted authorizing reconsidering the action of October 17, 1946 and authorizing the transfer of jurisdiction over 106.68 acres of filled tide and submerged lands in San Diego Bay adjacent to Silver Strand State Park to the State Park Commission, subject to the conditions that the lands be used for recreational purposes, and if acquired by the United States Government, that the consideration for the acquisition be paid into the State Lands Fund.

11. (Tidewater Associated Oil Company - Lease No. P.R.C. 153 - Tide and Submerged Lands in Sacramento River - Sacramento, California, W.O. 460) The Commission was informed that the Tidewater Associated Oil Company now holds Lease P.R.C. 153 covering approximately 0.36 acre of tide and submerged land in the Sacramento River at Sacramento. The Tidewater Associated Oil Company requests that they be permitted to sub-lease Parcel 2 consisting of .0503 acre to the Union Oil Company.

Upon motion duly made and unanimously carried, a resolution was adopted authorizing the Executive Officer to approve the sub-lease by Tidewater Associated Oil Company to the Union Oil Company of that portion of lease P.R.C. 153 described in the lease as Parcel 2 comprising .0503 acre of tide and submerged land in the Sacramento River at Sacramento.
