

17. (AMENDMENT OF SUBMARINE GEOPHYSICAL EXPLORATION PERMITS, HUMBLE OIL & REFINING COMPANY - P.R.C. 717.1, W.O. 1235; P.R.C. 724.1, W.O. 1254.) Review of the terms and conditions of submarine geophysical exploration permits authorized by the Commission for issuance to Humble Oil & Refining Company on August 21, 1952 (Minute Page 1619, Item 36, and Minute Page 1620, Item 37), has shown that subject permits in the general form authorized by the Commission on September 25, 1949 (Minute Page 1003, Item 24), do not contain any provision requiring the permittee to indemnify the State against any loss or action resulting from operations conducted under such permits. With the concurrence of the permittee, the following language has been added to Permit P.R.C. 717.1 and P.R.C. 724.1, effective September 22, 1952:

"11. The permittee agrees to indemnify the State against any and all losses, damages, claims, demands, or actions caused by, arising out of, or connected with the operations of the permittee hereunder."

UPON MOTION DULY MADE AND UNANIMOUSLY CARRIED, A RESOLUTION WAS ADOPTED APPROVING THE ADDITION OF SECTION 11, AS FOLLOWS, TO SUBMARINE GEOPHYSICAL EXPLORATION PERMITS P.R.C. 717.1 AND P.R.C. 724.1, EFFECTIVE SEPTEMBER 22, 1952, AND AUTHORIZING THE INCLUSION OF THIS PROVISION IN THE STANDARD FORM OF THE SUBMARINE GEOPHYSICAL EXPLORATION PERMIT FOR FUTURE ISSUANCE:

"11. THE PERMITTEE AGREES TO INDEMNIFY THE STATE AGAINST ANY AND ALL LOSSES, DAMAGES, CLAIMS, DEMANDS, OR ACTIONS CAUSED BY, ARISING OUT OF, OR CONNECTED WITH THE OPERATIONS OF THE PERMITTEE HEREUNDER."

18. (APPLICATION FOR PERMIT TO INSTALL A RECORDER STATION, SAN JOAQUIN RIVER AT DURHAM FERRY BRIDGE, SAN JOAQUIN COUNTY, U. S. BUREAU OF RECLAMATION - W.O. 1311, P.R.C. 766.1.) The U. S. Bureau of Reclamation has applied for a permit to install a recorder station in the San Joaquin River at Durham Ferry Bridge near Vernalis. No fees or rentals are required.

UPON MOTION DULY MADE AND UNANIMOUSLY CARRIED, A RESOLUTION WAS ADOPTED AUTHORIZING THE EXECUTIVE OFFICER TO ISSUE A PERMIT TO THE U. S. BUREAU OF RECLAMATION TO INSTALL A RECORDER STATION IN THE SAN JOAQUIN RIVER AT DURHAM FERRY BRIDGE, SAN JOAQUIN COUNTY, FOR SUCH PERIOD OF TIME AS THE PROPOSED INSTALLATIONS ARE MAINTAINED AND USED, THE CONSIDERATION BEING THAT THE PROJECT IS IN THE INTEREST OF THE PUBLIC.

19. (APPLICATION FOR PERMIT TO INSTALL A RECORDER STATION, SAN JOAQUIN RIVER AT TWITCHELL ISLAND, SAN JOAQUIN COUNTY, U. S. BUREAU OF RECLAMATION - W.O. 1287, P.R.C. 767.1.) The U. S. Bureau of Reclamation has applied for a permit to install a recorder station in the San Joaquin River at Twitchell Island. No fees or rentals are required.

UPON MOTION DULY MADE AND UNANIMOUSLY CARRIED, A RESOLUTION WAS ADOPTED AUTHORIZING THE EXECUTIVE OFFICER TO ISSUE TO THE U. S. BUREAU OF RECLAMATION A PERMIT TO INSTALL A RECORDER STATION IN THE SAN JOAQUIN RIVER AT TWITCHELL ISLAND, SAN JOAQUIN COUNTY, FOR SUCH PERIOD OF TIME AS THE PROPOSED INSTALLATIONS ARE MAINTAINED AND USED, THE CONSIDERATION BEING THAT THE PROJECT IS IN THE INTEREST OF THE PUBLIC.
