

9. (SALE OF VACANT SCHOOL LAND, APPLICATION NO. 10790, LOS ANGELES LAND DISTRICT, RIVERSIDE COUNTY, LOUIS MATTIS - S.W.O. 6005.) The following report was presented to the Commission:

"An offer has been received from Louis Mattis of Hollywood, California, to purchase Section 16, T. 7 S., R. 21 E., S.B.M., containing 640 acres in Riverside County. Mr. Mattis made an offer of \$1,280, or \$2 per acre.

"The Assessor of Riverside County has assessed contiguous land at \$1 to \$3 per acre, thus indicating its appraised value to be \$2 to \$6 per acre.

"An inspection and appraisal by a member of the Commission's staff on March 30, 1955 establishes the value of the subject land at \$7 per acre.

"Before the land was advertised for sale, Mr. Mattis was advised that the appraised value was \$7 per acre. He posted the necessary amount to meet the appraised value of \$4,480.

"Prior to advertising the application (10815, Los Angeles Land District, S.W.O. 6054) of Bruce Kratka was received and filed. Mr. Kratka made an offer of \$2 per acre which was not increased pursuant to advertising.

"The land was advertised for sale with a stipulation that no offer of less than \$4,480 would be accepted. No other application was received pursuant to the advertising."

"The Assessor of Modoc County has assessed similar land at \$1.75 to \$2.25 per acre, thus indicating its appraised value to be \$3.50 to \$4.50 per acre.

"An inspection and appraisal by a member of the Commission's staff on April 5, 1955 establishes the value of the subject land at \$2 per acre.

"The land was advertised for sale with a stipulation that no offer of less than \$1,280 would be accepted. No other application was received pursuant to the advertising."

"The Assessor of Lassen County has assessed contiguous land at \$2.50 per acre, thus indicating its appraised value to be \$5 per acre.

"An inspection and appraisal by a member of the Commission's staff on April 5, 1955 establishes the value of the subject land at \$2.75 per acre.

"Before the land was advertised for sale, Mr. Foster was advised that the appraised value was \$2.75 per acre. He posted the necessary amount to meet the appraised value of \$1,760.

"The land was advertised for sale with a stipulation that no offer of less than \$1,760 would be accepted. No other application was received pursuant to the advertising.

"Approximately one-quarter of an acre of land within said section is currently under lease to the Pacific Telephone and Telegraph Company for the purpose of constructing and maintaining a telephone repeater station building and necessary adjuncts thereto.
