(AMENDMENT OF OIL AND GAS LEASE P.R.C. 1466.1, RICHFIELD OIL CORPORATION, RINCON FIELD, VENTURA COUNTY - W. O. 2908.)

State Oil and Gas Lease P.R.C. 1466.1 was issued on August 29, 1955 to the Richfield Oil Corporation, pursuant to competitive public bidding, in accordance with Division 6 of the Public Resources Code, covering approximately 1,175 acres of tide and submerged land in the Rincon Field, Ventura County.

An application has been received from the Richfield Oil Corporation requesting that the terms of the lease be modified as provided for under Section 6873 of the Public Resources Code, as amended by Chapter 104 of the Statutes of 1957, in order that the lassee may take advantage of the more flexible operating and development conditions specified.

It is the opinion of the office of the Attorney General that Oil and Gas Lease P.R.C. 1466.1 may be modified in accordance with the provisions of Section 6873 of the Public Resources Code.

IT IS RECOMMENDED THAT THE COMMISSION APPROVE THE MODIFICATION OF THE TERMS OF OIL AND GAS LEASE P.R.C. 1466.1, AS REQUESTED BY THE RICHFIELD OIL CORPORA-TION, BY THE SUBSTITUTION OF THE PROVISIONS OF CHAPTER 10¹⁴ OF THE STATUTES OF 1957, ALL OTHER TERMS, CONDITIONS, AND PERFORMANCE REQUIREMENTS UNDER THE LEASE TO REMAIN UNCHANGED AND IN FULL FORCE AND EFFECT.
