After consideration of Calendar Item 25 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE A 49-YEAR EASEMENT TO KENNETH E. ANDERSON FOR A ROADWAY, A WATER PIPE LINE, AND A POWER-POLE LINE, AT A TOTAL RENTAL OF \$556.64, PAYABLE IN ADVANCE, COVERING THE FOLLOWING-DESCRIBED STATE SCHOOL LANDS:

A STRIP OF LAND 20 FEET IN WIDTH IN THE $SE_{\frac{1}{4}}^{1}$ OF $NE_{\frac{1}{4}}^{1}$ OF SECTION 36, T. 9 N., R. 22 E., S.B.B.& M., SAN BERNARDINO COUNTY, THE CENTERLINE BEING DESCRIBED AS FOLLOWS:

BEGINNING AT A POINT ON THE EAST LINE OF SECTION 36 WHICH BEARS N. 0° 02' E., 10 FEET FROM THE EAST QUARTER CORNER OF SAID SECTION; THENCE WESTERLY AND PARALLEL TO THE SOUTH LINE OF SAID $SE^{\frac{1}{4}}$ OF $NE^{\frac{1}{4}}$ OF SECTION 36, 1,320 FEET, MORE OR LESS, TO THE WEST LINE OF SAID $SE^{\frac{1}{4}}$ OF $NE^{\frac{1}{4}}$ OF SECTION 36, CONTAINING 0.606 ACRE, MORE OR LESS.

APPLICATION FOR EASEMENT, STATE SCHOOL LANDS SOUTHWEST OF NEEDLES, SAN BERNARDINO COUNTY, KENNETH E. ANDERSON - W.O. 3750.

An application has been received from Kenneth E. Anderson for an easement 20 feet in width, crossing the southerly 20 feet of the E_2^1 of the NE_4^1 of Section 36, T. 9 N., R. 22 E., S.B.B.& M., located about two miles from downtown Needles in San Bernardino County. The approximately 1,320-footlong easement is to be used as an access roadway and as the site for a water line and a power-pole line to service the applicant's residence to be located on adjacent property, which was State school land until patent was issued in 1937. The proposed easement crosses a large dry wash in an area subject to flash flooding. The 0.6-acre parcel of State lands to be occupied has been appraised by the staff at \$200 per acre, for a total value of \$120. Total rental for a 49-year term is to be \$556.64, payable in advance, in accordance with previously established Commission policy. Issuance of the requested easement would not have any deleterious effect on the remainder of the State-owned school land in Section 36.

The expense deposit and filing fas have been paid. No bond is required.
