After consideration of Calendar Item 25 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE A 15-YEAR PERMIT TO THE STATE DIVISION OF BEACHES AND PARKS TO INSTALL AND MAINTAIN A FLOATING WHARF, APPROXIMATELY ONE MILE UPSTREAM FROM COLUSA BRIDGE, ON A PARCEL OF SUBMERGED LAND ALONG THE RIGPT BANK OF THE SACRAMENTO RIVER AT THE COLUSA-SACRAMENTO RIVER STATE PARK, COLUSA COUNTY, DESCRIBED AS FOLLOWS:

BEGINNING AT A POINT ON THE LOW WATER MARK ALONG THE RIGHT BANK OF THE SACRAMENTO RIVER WHICH BEARS N. 45° 44' E., 2,173 FEET, MORE OR LESS, FROM THE INTERSECTION OF THE CENTERLINES OF 12TH AND MAIN STREETS IN THE CITY OF COLUSA; THENCE FROM THE POINT OF BEGINNING RUNNING NORTHEASTERLY ALONG SAID LOW WATER MARK 250 FEET; THENCE INTO THE SACRAMENTO RIVER AT RIGHT ANGLES 20 FEET; THENCE SOUTHWESTERLY PARALLEL TO SAID LOW WATER MARK 250 FEET; THENCE AT RIGHT ANGLES 20 FEET TO THE POINT OF BEGINNING, CON-TAINING 0.115 ACRE, MORE OR LESS.

APPLICATION FOR FLOATING WHARF, SUBMERGED LAND ALONG RIGHT BANK OF SACRAMENTO RIVER NEAR COLUSA, COLUSA COUNTY, STATE DIVISION OF BEACHES AND PARKS - W.O. 3866.

An application has been received from the State Division of Beaches and Parks for a 15-year permit to install a floating wharf along the right bank of the Sacramento River, adjoining the Colusa-Sacramento River State Park, approximately one mile upstream from Colusa Bridge. The wharf will occupy a surip of submerged land 250 feet in length and 20 feet in width along the river bank, and will be in portable sections for removal during the flood season. No fees or charges are required by statute or regulations.

IT IS RECOMMENDED THAT THE EXECUTIVE OFFICER BE AUTHORIZED TO ISSUE A 15-YEAR PERMIT TO THE STATE DIVISION OF BEACHES AND PARKS TO INSTALL AND MAINTAIN A FLOATING WHARF, APPROXIMATELY ONE MILE UPSTREAM FROM COLUSA BRIDGE, ON A PARCEL OF SUBMERGED LAND ALONG THE RIGHT BANN OF THE SACRAMENTO RIVER AT THE COLUSA-SACRAMENTO RIVER STATE PARK, COLUSA COUNTY, DESCRIBED AS FOLLOWS:

BEGINNING AT A POINT ON THE LOW WATER MARK ALONG THE RIGHT BANK OF THE SACRAMENTO RIVER WHICH BEARS N. 45° 44' E., 2,173 FEET, MORE OR LESS, FROM THE INTERSECTION OF THE CENTERLINES OF 12TH AND MAIN STREETS IN THE CITY OF COLUSA; THENCE FROM THE PO'NT OF BEGINNING RUNNING NORTHEASTERLY ALONG SAID LOW WATER K 250 FEET; THENCE INTO THE SACRAMENTO RIVER AT RIGHT ANGLES 20 FEET; THENCE SOUTHWESTERLY PARALLEL TO SAID LOW WATER MARK 250 FEET; THENCE AT RIGHT ANGLES 20 FEET TO THE POINT OF BEGINNING, CONTAINING 0.115 ACRE, MORE OR LESS.
