APPLICATION FOR LEASE OF THE  $NE_{4}^{1}$  OF THE  $NV_{4}^{1}$ , SECTION 16, T. 5 S., R. 16 E., S.B.B.& M., RIVERSIDE COUNTY, UNITED STATES OF AMERICA - W.O. 3551.

An application has been received from the United States of America, acting through the Federal Aviation Agency, to lease the  $NE_{4}^{1}$  of the  $NW_{4}^{1}$  of Section 16, T. 5 S., R. 16 E., S.B.B.& M., containing 40 acres, more or less, in Riverside County, for use as a part of a landing field at Desert Center, California (see Exhibit "A").

The leasehold interest in the subject site was acquired by the United States under the Second War Powers Act on November 9, 1942. Subsequently, a lease was issued to the United States of America on April 28, 1950, at an annual rental of \$1.20. The lease provided for automatic annual renewal, the last renewal being for the period ended June 30, 1961.

The Federal Aviation Agency has submitted an application for a short-term lease for the period July 1, 1961, to June 30, 1962, as they may wish to terminate the landing facility at any time. The annual rental is to be \$100.
