After consideration of Calendar Item 25 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE A 10-YEAR LEASE TO JCHN A. DICK, EFFECTIVE OCTOBER 1, 1960, AT AN ANNUAL RENTAL OF \$65, WITH THE FIRST AND LAST YEARS' RENTAL PAYABLE IN ADVANCE, FOR THE USE OF CERTAIN TIDE AND SUBMERGED LANDS OF FETALUMA CREEK AS AN ARK SITE, THE LANDS BEING DESCRIBED AS FOLLOWS:

APPLICATION FOR ARK SITE LEASE ON PETALUMA CREEK AT BLACK POINT, MARIN COUNTY, JOHN A. DICK - W.O. 3701.

An application has been received from John A. Dick for a 10-year lease of a portion of the tide and submerged lands along the right bank of Petaluma Creek at Black Point, Marin County, for an ark site. The lease would replace Lease P.R.C. 1810.1, which expired on September 30, 1960.

An inspection of the area indicates no enhancement in value which would justify an increase in the annual rental of \$65.00. The Marin County Planning Department has expressed no objection to the reissuance of the lease. The statutory filing fee has been paid. No bond is required.
