THE EXECUTIVE OFFICER IS AUTHORIZED TO EXTEND THE TERM OF MINERAL EXTRACTION LEASE P.R.C. 11.2, INYO COUNTY, AS REQUESTED BY THE LESSEE, SIERRA TALC COMPANY, FOR A PERIOD OF 10 YEARS COMMENCING TBRUARY 25, 1962. ALL OTHER TERMS AND CONDITIONS OF THE LEASE ARE TO REMA... IN FULL FORCE AND EFFECT.

REQUEST FOR EXTENSION OF TERM, MINERAL EXTRACTION LEASE F.R.C. 11.2, SIERRA TALC COMPANY, INYO COUNTY - W.O. 4204.

Mineral Extraction Lease P.R.C. 11.2, covering the $SE_{\frac{1}{4}}^{\frac{1}{4}}$ of the $NE_{\frac{1}{4}}^{\frac{1}{4}}$ of Section 36, T. 18 S., R. 39 E., M.D.B.& M., Inyo County, was issued on February 25, 1942, to the Sierra Talc Company, pursuant to competitive public bidding, for a term of 20 years.

An application has been received from the Sierra Talc Company requesting an extension of the lease term from February 25, 1962, to February 24, 1972, inclusive. Section 1 of the lease provides, in part "... with the preferential right in the lessee to renew this lease for successive periods of 10 years upon such reasonable terms and conditions as may be prescribed by the State Lands Commission". Talc, the mineral extracted from the State land, is an inferior grade used in the ceramic industry. During the year ending September 30, 1961, 869 tons of tale was mined and a royalty of \$1,416 paid to the State. Cumulative royalty received through September 30, 1961, was \$32,634. The royalty rate for ore mined or removed from the premises is \$1.25 per ton.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO EXTEND THE TERM OF MINERAL EXTRACTION LEASE P.R.C. 11.2, INYO COUNTY, AS REQUESTED BY THE LESSEE, SIERRA TALC COMPANY, FOR A PERIOD OF 10 YEARS COMMENCING FEBRUARY 25, 1962. ALL OTHER TERMS AND CONDITIONS OF THE LEASE ARE TO REMAIN IN FULL FORCE AND EFFECT.
