APPLICATION FOR 49-YEAR LIFE-OF-STRUCTURE PERMIT FOR TIDE-RECORDING STATION IN SAN JOAQUIN RIVER, SAN JOAQUIN COUNTY; CITY OF STOCKTON - W.O. 4083.

The City of Stockton has applied for a permit to construct and maintain a tide-recording gauge on submerged lands in the San Joaquin River. The gauge will be located on the north bank of the San Joaquin River just south of the City of Stockton's sewage treatment plant.
