## MINUTE ITEM

5. APPLICATION FOR AMENDMENT OF LEGAL DESCRIPTION OF LIFE-OF-STRUCTURE PERMIT P.R.C. 1364.9, TIDE AND SUBMERGED LANDS OF THE PACIFIC OCEAN IN CITY AND COUNTY OF SAN FRANCISCO; NORTH SAN MATEO SANITATION DISTRICT - W.O. 4324.

After consideration of Calendar Item 9 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO AMEND THE LEGAL DESCRIPTION OF LIFE-OF-STRUCTURE PERMIT P.R.C. 1364.9 FOR THE PURPOSE OF EXTENDIANT THE SEWER OUTFALL CONSTRUCTED ON THE PERMITTED LANDS, WITH THE NEW DESCRIPTION TO READ:

A STRIP OF LAND LOO FEET IN WIDTH, LYING 50 FEET ON EACH SIDE OF A CENTERLING EXTENDING S. 87° 22' 37" W., 17LO FRET MORE OR LESS, SEAWARD OF THE MEAN HIGH WATER LINE OF THE PACIFIC OCEAN, WHOM A POINT ON SAID MEAN HIGH WATER LINE WHICH BEARS S. 87° 22' 37" W., SO FEET MORE OR LESS, FROM A POINT ON THE WESTERLY LINE C+ THE LANDS OF THE UNITED STATES OF AMERICA, VETERANS ADMINISTRATION, WHICH IS THE POINT OF INTERSECTION OF SAID WESTERLY LINE WITE THE CENTERLING OF THAT CERTAIN DRAINAGE EASEMENT DESCRIBED IN DEED RECORDED AUGUST 7, 1917, IN BOOK 1028 OF DEEDS, PAGE 119, OFFICIAL RECORDS OF THE CITY AND COUNTY OF SAN FRANCISCO, SAID POINT ALSO BEARING N. 16° 31' 07" W., 1241.20 FEET, FROM THE MOST SOUTHERLY CORNER OF SAID LANDS OF THE UNITED STATES OF AMERICA, CONTAINING 3.926 ACRES MORE OR LESS, IN THE CITY AND COUNTY OF SAN FRANCISCO.

ALL OTHER CONDITIONS OF PERMIT P.R.C. 1364.9 ARE TO REMAIN IN FULL FORCE AND EFFECT. THE CONSIDERATION IS THE PUBLIC USE AND BENEFIT.

APPLICATION FOR AMENDMENT OF LEGAL DESCRIPTION OF LIFE-OF-STRUCTURE PERMIT P.R.C. 1364.9, TIDE AND SUBMERGED LANDS OF THE PACIFIC OCEAN IN CITY AND COUNTY OF SAN FRANCISCO; NORTH SAN MATEO SANITATION DISTRICT - V.O. 4324.

Life-of-Structure Permit P.R.C. 1364.9 was issued on April 24, 1954, to the North San Mateo Sanitation District, for the construction, maintenance, and operation of a sewer outfall. The District now wishes to extend the outfall, as required by the State Water Pollution Control Board, and has applied for an amendment of the legal description of Permit P.R.C. 1364.9 to provide a 1500-foot extension of the right-of-way.

IT IS RECOMMENDED THAT THE EXECUTIVE OFFICER BE AUTHORIZED TO AMEND THE LEGAL DESCRIPTION OF LIFE-OF-STRUCTURE PERMIT P.R.C. 1364.9 FOR THE PURPOSE OF EXTENDING THE SEVER OUTFALL CONSTRUCTED ON THE PERMITTED LANDS, WITH THE NEW DESCRIPTION TO READ:

STRIP OF LAND 100 FEET IN WIDTH, LYING 50 FEET ON EACH SIDE OF A CENTERLINE EXTENDING S. 87° 22' 37" W., 1710 FEET MORE OR LESS, SEAVARD OF THE MEAN HIGH WATER LINE OF THE PACIFIC OCEAN, FROM A POINT ON SAID MEAN HIGH WATER LINE WHICH BEARS S. 87° 22' 37" W., 90 FEET MORE CR LESS, FROM A POINT ON THE WESTERLY LINE OF THE LANDS OF THE UNITED STATES OF AMERICA, VETERANS AIMINISTRATION, WHICH IS THE POINT OF INTERSECTION OF SAID WESTERLY LINE WITH THE CENTERLINE OF THAT CERTAIN DRAINAGE EASEMENT DESCRIBED IN DEED RECORDED AUGUST 7, 1917, IN BOOK 1028 OF DEEDS, PAGE 119, OFFICIAL RECORDS OF THE CITY AND COUNTY OF SAN FRANCISCO, SAID POINT ALSO BEARING N. 16° 31' 07" W., 1241.20 FEET, FROM THE MOST SOUTHERLY CORNER OF SAID LANDS OF THE UNITED STATES OF AMERICA, CONTAINING 3.926 ACRES MORE OR LESS, IN THE CITY AND COUNTY OF SAN FRANCISCO.

ALL OTHER CONDITIONS OF PERMIT P.R.C. 1364.9 ARE TO REMAIN IN FULL FORCE AND EFFECT. THE CONSIDERATION IS THE PUBLIC USE AND BETEFIT.
