9. APPLICATION FOR PERMIT TO CONSTRUCT PUBLIC FISHING ACCESS, INCLUDING A FLOAT AND BOAT-LAUNCHING RAMP, SUBMERGED LANDS OF HUDEMAN SLOUGH, SONOMA COUNTY; DEPARTMENT OF FISH AND GAME - W.O. 4316, P.R.C. 2887.9.

After consideration of Calendar Item 23 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE A 49-YEAR PERMIT TO THE DEPARTMENT OF FISH AND GAME, STATE OF CALIFORNIA, FOR A PUBLIC FISHING ACCESS WHICH IS TO INCLUDE A FLOAT AND BOAT-LAUNCHING RAMP, IN AN AREA DESCRIBED AS FOLLOWS:

A PARCEL OF SUBMERGED LAND IN HUDEMAN SLOUGH, SONOMA COUNTY, BEING DESCRIBED AS POLLOWS:

BEGINNING AT THE INTERSECTION OF COURSE NO. 257 AND COURSE NO. 258 ALONG THE SOUTHERLY BOUNDARY OF PARCEL 5 AS SHOWN ON RECORD OF SURVEY MAP OF PROPERTIES OF M. B. SKAGGS AND ESTELLA I. SKAGGS, SONOMA COUNTY, CALIFORNIA, FILED SEPTEMBER 4, 1953, IN BOOK 54 OF MAPS AT PAGES 7 TO 12, INCLUSIVE, IN THE OFFICE OF THE COUNTY RECORDER OF SONOMA COUNTY; THENCE FROM SAID POINT OF BEGINNING S. 17° OO' E., 160.0 FEET; THENCE N. 73° OO' E. 68.4 FEET TO SAID COURSE NO. 257; THENCE ALONG SAID COURSE N. 40° OS' 10" W., 174.0 FEET MORE OR LESS TO THE POINT OF BEGINNING, AND CONTATING 0.13 ACRE MORE OR LESS.

APPLICATION FOR PERMIT TO CONSTRUCT PUBLIC FISHING ACCESS, INCLUDING A FLOAT AND BOAT-LAUNCHING RAMP, SUBMERGED LANDS OF HUDEMAN SLOUGH, SONOMA COUNTY; DEPARTMENT OF FIGH AND GAME - V.O. 4316.

The Department of Fish and Game proposes to construct a public fishing access facility, portions of which will occupy submerged lands of Hudeman Slough, Sonoma County. The overall project will include a parking area, float and boat-launching ramp; the latter two structures will be built almost entirely on State land. The project site is about eight miles southwest of the City of Napa (see Exhibit "A").
