25. APPLICATION FOR RIGHT-OF-WAY EASEMENT OVER TIDE AND SUBMERGED LANDS OF LATHAM SLOUGH, SAN JOAQUIN COUNTY; PACIFIC GAS AND ELECTRIC COMPANY -W.O. 4375, P.R.C. 2907.1.

After consideration of Calendar Item 40 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO PACIFIC GAS AND ELECTRIC COMPANY A 49-YEAR RIGHT-OF-WAY EASEMENT FOR A TOTAL RENTAL OF \$108.78 OVER THE FOLLOWING-DESCRIBED LANDS:

A STRIP OF LAND 10 FEET IN WIDTH IN THE OLD BED OF LATHAM SLOUGH, SAN JOAQUIN COUNTY, PRIOR TO LEVEE CONSTRUCTION, LYING 5 FEET ON EACH SIDE OF THE FOLLOWING-DESCRIBED CENTER LINE:

BEGINNING AT TRIANGULATION STATION "BACON - 1931" (ZONE III, LAMBERT COORDINATES X = 1,703,500.35, Y = 531,950.58); THENCE N. 35° 51' E. 7804.3 FEET; AND THENCE N. 62° 00' E. 302 FEET TO A POINT ON THE ORDINARY HIGH WATER MARK ON THE WEST BANK OF LATHAM SLOUGH, WHICH POINT IS THE TRUE FOINT OF BEGINNING OF THE ABOVE-DESCPIBED CENTER LINE; THENCE CONTINUING N. 62° 00' E. 170 FEET MORE OR LESS TO A POINT ON THE ORDINARY HIGH WATER MARK ON THE EAST BANK OF LATHAM SLOUGH, AND CONTAINING .039 ACRE MORE OR LESS.

APPLICATION FOR RIGHT-OF-WAY EASEMENT OVER TIDE AND SUBMERGED LANDS OF LATHAM SLOUGH, SAN JOAQUIN COUNTY; PACIFIC GAS AND ELECTRIC COMPANY - W.O. 4375.

Pacific Gas and Electric Company has applied for a right-of-way easement over 0.039 acre of tide and submerged lands of Latham Slough, San Joaquin County (see Exhibits "A" and "B"), to be used for a crossing for a 22inch diameter gas-line pipe which is to be buried a minimum of five feet in the slough bottom. The crossing is not within the corporate limits of any municipality.

On the basis of previously established rates, the total rental for 49 years has been calculated to be \$108.78.

IT IS RECOMMENDED THAT THE EXECUTIVE OFFICER BE AUTHORIZED TO ISSUE TO PACIFIC GAS AND ELECTRIC COMPANY A 49-YEAR RIGHT-OF-WAY EASEMENT FOR A TOTAL RENTAL OF \$108.78 OVER THE FOLLOWING-DESCRIBED LANDS:
