Application has been received from the State Division of Highways, pursuant to Section 101.5 of the Streets and Highways Code, for the use for right-ofway purposes of 3.716 acres more or less of tide and submerged lands of the Sacramento River in portions of Township 8 North, Range 4 East, M-D.B.& M., in the City of Sacramento, Sacramento and Yolo Counties, for the protection, construction and maintenance of a bridgeon State Highway route "III-Yol, Sac-6-c, Sac." The structure will provide a minimum clearance of 55 feet above flood plane level.
