Location: The town of Lucerne Valley is eight and three-fourths miles west-northwest. Apple Valley and Victorville are fourteen and twentyone road-miles, respectively, westerly of Lucerne Valley.

Access: Old Woman Springs Highway, which is a two-lane paved road, passes one and one-half miles north. From this highway a dirt road runs south to and along the west boundary of the parcel.

Highest Use: Homesites.

The applicant did not wish to proceed with acquisition of the land, and at his request the application was cancelled prior to the completion of any appraisal work.

The selection of the subject land is considered to be to the advantage of the State in that it will assist in satisfying deficiencies under the School Land Grant.

The State's application to relect the land has been accepted by the Bureau of Land Management, and the land was listed (conveyed) to the State on May 23, 1962.

IT IS RECOMMENDED THAT THE COMMISSION:
