28. AMENDMENT OF GEOLOGICAL SURVEY PERMIT P.R.C. 2791.1; SANTA BARBARA, VENTURA, LOS ANGELES, AND ORANGE COUNTIES; RICHFIELD OIL CORPORATION - W.O. 5023.

After consideration of Supplemental Calendar Item 25 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO AMEND GEOLOGICAL EXPLORATION PERMIT P.R.C. 2791.1 TO AUTHORIZE EXPLORATION ON THOSE TIDE AND SUBMENCED LANDS JNDER THE JURISDICTION OF THE STATE LANDS COMMISSION IN THE AREA LYING BETWEEN THE PROLONGATION SEAWARD OF THE NORTHERLY CORPORATE LIMITS OF THE CITY OF NEWPORT BEACH, ORANGE COUNTY, AND A LINE DRAWN DUE WEST FROM FOINT ARGUELLO, SANTA BARBARA COUNTY, EXTENDING SHOREWARD OF THE "OPERATIONS LINE" AS SUCH LINE WAS APPROVED BY THE STATE LANDS COMMISSION ON DECEMBER 6, 1962. AMENDMENT OF GEOLOGICAL SURVEY PERMIT P.R.C. 2791.1; SANTA BARBARA, VENTURA, LOS ANGELES, AND ORANGE COUNTIES; RICHFIELD OIL CORPORATION - W.O. 5023.

A request has been received from Richfield Oil Corporation for an amendment of the description of the area covered by Geological Survey Permit P.R.C. 2791.1. The present permit authorizes geological exploration in the area lying between a line drawn due West from Point Arguello, Santa Barbara County, and the prolongation seaward of the Los Angeles-Orange County line. It is requested that the area covered by the extension be described as follows:

"...lying between the prolongation seaward of the northerly corporate limits of the City of Newport Beach, Orange County, and the line drawn due West from Point Arguello, Santa Barbara County".
