APPLICATION FOR RENEWAL OF PIPELINE EASEMENT P.R.C. 498.1 ACROSS TIDE AND SUE-MERGED LANDS OF OLD RIVER IN CONTRA COSTA AND SAN JOAQUIN COUNTIES; FACIFIC GAS AND ELECTRIC COMPANY - W.O. 5539.

Lease P.R.C. 498.1, covering a 50-foot pipeline easement, and comprising 0.702 acre of tide and submerged land in Old River (as shown on Exhibit "A"), expired on February 9, 1965. The 15-year lease, which provided for an annual rental of \$52.24, and for two renewal options of 10 years each, was originally issued to the Standard Oil Company and later assigned to Natural Gas Corporation who, on March 3, 1960, further assigned it to Pacific Gas and Electric Company.

A staff appraisal indicates a total rent of \$265.20 for the 10-year renewal period.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO ISSUE A 10-YEAR RENEWAL OF LEASE P.R.C. 498.1, CONTRA COSTA AND SAN JOAQUIN COUNTIES, TO PACIFIC GAS AND ELECTRIC COMPANY, AT A TOTAL RENTAL OF \$265.20, THE RENEWAL TO BE EFFECTIVE AS OF FEBRUARY 10, 1965. ALL OTHER TERMS AND CONDITIONS OF LEASE P.R.C. 498.1 ARE TO REMAIN IN FULL FORCE AND EFFECT.
