After consideration of Calendar Item 15 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO PAN PETROLEUM COMPANY, INC., A GEOLOGICAL SURVEY PERMIT, CONFORMING TO ALL OPERATING CONDITIONS ESTABLISHED BY THE COMMISSION FOR THE CONDUCT OF GEOLOGICAL SURVEY OPERATIONS, ON THOSE TIDE AND SUBMERGED LANDS UNDER THE JURISDICTION OF THE STATE LANDS COMMISSION IN THE AREA LYING BETWEEN A LINE DRAWN DUE WEST FROM POINT CONCEPTION, SANTA BARBARA COUNTY, AND THE SOUTHERN BOUNDARY OF THE STATE OF CALIFORNIA.

THE PERMIT IS TO BE ISSUED FOR A SIX-MONTH PERIOD FROM DECEMBER 16, 1965, THROUGH JUNE 15, 1966.

THE PERMITTEE IS TO REIMBURSE THE STATE LANDS DIVISION FOR ALL OF THE INSPEC-TION COSTS.

APPLICATION FOR GEOLOGICAL SURVEY PERMIT; SANTA BARBARA, VENTURA, LOS ANGELES, ORANGE, AND SAN DIEGO COUNTIES; PAN PETROLEUM COMPANY, INC., - W.O. 5934.

An application has been received from Pan Petroleum Company, Inc., for a permit to conduct geological survey operations during the period of six months commencing December 16, 1965, covering the tide and submerged lands under the jurisdiction of the State Lands Commission in the area lying between Point Conception, Santa Barbara County, and the Mexican border.

The statutory filing fee has been paid by the applicant.
