4. PUBLIC AGENCY PERMIT (RIGHT-OF-WAY), NAPA RIVER, NAPA COUNTY; NAPA SANITATION DISTRICT - W.O. N-0098, P.R.C. 3966.9.

After consideration of Calendar Item 37 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE COMMISSION AUTHORIZES THE ISSUANCE TO NAPA SANITATION DISTRICT OF (1) A 49-YEAR PUBLIC AGENCY PERMIT (RIGHT-OF-WAY), FROM JUNE 1, 1968, IN CONSIDERATION OF THE PUBLIC HEALTH, FOR THE INSTALLATION OF A SEWER LINE TO BE CONSTRUCTED ON SOVEREIGN LANDS DESCRIBED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF; AND (2) A TEMPORARY RIGHT-OF-ENTRY PERMIT FOR CONSTRUCTION PURPOSES TO BEGIN JUNE 1, 1968, AND END NOT LATER THAN DECEMBER 1, 1969, WITHIN A PROJECT AREA LYING 30 FEET ON THE WESTERLY SIDE OF THE RIGHT-OF-WAY DESCRIBED ON EXHIBIT "A".

PUBLIC AGENCY PERMIT (RIGHT OF WAY)

APPLICANT: Napa Sanitation District

LOCATION: A permanent right-of-way within a project area of 10 x 200 feet extending across Napa River at a point northerly of the intersection of Third and Burnell Streets in the City of Napa, Napa County. Also, a temporary right-of-entry permit for construction purposes in a project area lying 30 feet on the westerly side of the permanent right-of-way.

PROPOSED USE: The installation of a 27" sanitary sewer line

TERM: 49 years, from June 1, 1968

CONSIDERATION: No charge (The public health)

PREREQUISITE ITEMS:
A U.S.A. Corps of Engineers Permit has been issued
Applicant is lessee or permittee of upland

Lessee: Napa Sanitation District

All that certain tide and submerged land in the Napa River, City of Napa, Napa County, within a 10-foot strip of land lying 5 feet on each side of the following described line:

BEGINNING at a point on the southerly bank of the Napa River from which the most southerly corner of Lot 2, Block 4 as shown on the map entitled "Map of East Napa", filed February 23, 1886, in Book 1 of Maps, page 58, in the office of the County Recorder of Napa County, California, bears South $5^{\circ} 37' 14''$ E 183.23 feet; thence N $9^{\circ} 19' 30''$ E 200 feet more or less to a point on the northerly bank of the Napa River from which the most northerly corner of Block 17 as shown on the map entitled "Cornwall's Addition to Napa City" filed in Book B of Deeds, page 143, in the office of said County Recorder bears N $13^{\circ} 9' 46''$ W 190.67 feet.
