

8. RIGHT-OF-ENTRY PERMIT, MISSION BAY, SAN DIEGO COUNTY; DEPARTMENT OF PUBLIC WORKS, DIVISION OF HIGHWAYS - W.O. 6969, P.R.C. 3970.9.

After consideration of Calendar Item 35 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

APPLICANT: Department of Public Works, Division of Highways

LOCATION: Mission Bay, San Diego

PROPOSED USE: Right-of-entry for, and for the protection of State Highway Route 11-SD-109

TERMS: Initial period: 1 year, from June 27, 1968

CONSIDERATION: The public use and benefit

OTHER PERTINENT INFORMATION:

In accordance with Section 101.5 of the Streets and Highways Code, the State Division of Highways has filed a map and tracings delineating an area of tidelands needed for highway purposes in Mission Bay, San Diego. Inasmuch as immediate entry is required, a right-of-entry permit has been requested as to whatever interest the State may have, pending completion of a review by staff as to the extent of State interest as delineated on the map, since a question exists as to whether the title to the land is held by the State or by other parties. If the review confirms State ownership, a subsequent recommendation will be made for approval under Section 101.5 of the Streets and Highways Codes.
