

9. RESERVATION OF LANDS FOR HIGHWAY PURPOSES, SOVEREIGN LAND, HUMBOLDT BAY, HUMBOLDT COUNTY; STATE DEPARTMENT OF PUBLIC WORKS, DIVISION OF HIGHWAYS - W.O. 6187, P.R.C. 3971.9.

After consideration of Calendar Item 29 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE COMMISSION AUTHORIZES THE EXECUTION OF AN AGREEMENT WITH THE STATE DIVISION OF HIGHWAYS, PURSUANT TO SECTION 101.5 OF THE STREETS & HIGHWAYS CODE, FOR THE RESERVATION OF UNGRANTED SOVEREIGN LAND FOR HIGHWAY AND BRIDGE PURPOSES ACROSS ARCATA (a.k.a. SAMOA) CHANNEL IN HUMBOLDT BAY, HUMBOLDT COUNTY, BEING A PORTION OF SECTION 15, T. 5 N., R. 1 W., H.B.M., AS SHOWN ON HIGHWAYS MAP 01-HUM-255-0.0/2.0; PROVIDED THAT SUCH AGREEMENT AND RELATED MAP SHALL BE WITHOUT REPRESENTATION AS TO WHICH, IF ANY, OF THE LAND INCLUDED IS IN FACT SOVEREIGN LAND.

APPLICANT: State Department of Public Works, Division of Highways

LOCATION: A strip of ungranted sovereign land across Arcata (a.k.a. Samoa) Channel in Humboldt Bay, Humboldt County

PROPOSED USE: The construction of a highway bridge

TERM: No time limitation and no rental, pursuant to Section 101.5 of the Streets & Highways Code

PREREQUISITE ITEM: U.S.A. Corps of Engineers navigational permit issued

## OTHER PERTINENT INFORMATION:

The land covered by this transaction includes an area within Swamp and Overflowed Lands Survey 84, the validity of which is subject to question. Additional research is required to make a firm determination of the State's boundary. In order to permit the Division of Highways to proceed with construction, the authorization hereinafter recommended provides for appropriate disclaimer as to the extent of sovereign land covered.
