

53. INTERAGENCY AGREEMENT WITH DEPARTMENT OF JUSTICE FOR SERVICES RELATED TO LONG BEACH RESPONSIBILITIES - W.O. 5200.209.3, P & C.

INTERAGENCY AGREEMENT WITH DEPARTMENT OF JUSTICE FOR
SERVICES RELATED TO LONG BEACH RESPONSIBILITIES

PURPOSE: To provide for legal services of the Attorney General's office for the 1968-69 fiscal year, under service contract, for the Division's Long Beach responsibilities under Ch. 29/56, 1st E.S., and Ch. 138/64, 1st E.S.

CONTRACTOR: Department of Justice, Attorney General

CONTRACT TERMS: Period: July 1, 1968, through June 30, 1969
Cost: Estimated \$80,000

PERTINENT INFORMATION:

Attorney General's services needed for:

1. Alamitos Bay investigation and possible confirmatory litigation
2. Pending and prospective litigation involving the imposition of ad valorem taxes on mineral rights in the Long Beach tidelands
3. Long Beach Unit business, including attendance at Long Beach Unit meetings, preparation of plans and budgets, cooperative agreements, and related matters
4. Negotiations for Decree in People v. City of Long Beach, L.A. Superior Court Nos. 649466 and 747562
5. Pending and imminent boundary litigation in Long Beach Amusement Co. v. Atlantic Richfield Co., L.A. Superior Court No. SOC 17173
6. Miscellaneous Long Beach matters, such as subsidence-cost negotiations, gas-pricing investigation and negotiations, oil-pricing investigation, and approvals of expenditures of tideland trust moneys
