50. AWARD OF OIL AND GAS LEASE, PARCEL 60, CARPINTERIA, SANTA BARBARA COUNTY; STANDARD OIL COMPANY OF CALIFORNIA, AND ATLANTIC RICHFIELD COMPANY - W.O. 6945, P.R.C. 4000.1.

After consideration of Calendar Item 51 attached, and upon motion duly made and carried, the following resolution was adopted:
