22. EXTENSION OF DREDGING PERMIT P.R.C. 3690.9, T&S LANDS NEAR MOUTH OF THE RUSSIAN RIVER IN SONOMA COUNTY; UTAH CONSTRUCTION & MINING CO. - W.O. 7358.

After consideration of Calendar Item 13 attached, and upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION AUTHORIZES THE EXTENSION THROUGH JUNE 28, 1970, OF DREDGING PERMIT P.R.C. 3690.9, COVERING AN AREA OF STATE-OWNED TIDE AND SUBMERGED LANDS NEAR THE MOUTH OF THE RUSSIAN RIVER, SONOMA COUNTY; ALL OTHER TERMS AND CONDITIONS OF PERMIT P.R.C. 3690 9 ARE TO REMAIN IN FULL FORCE AND EFFECT.

EXTENSION OF DREDGING PERMIT

PERMIT: P.R.C. 3690.9

PERMITTEE: Utah Construction & Mining Co.

LOCATION: Tide and submerged lands near the mouth of the Russian River, Sonoma County.

ORIGINAL AMOUNT TO BE DREDGED: 158,000 cubic yards.

DISPOSITION: Transported seaward and redeposited on State lands.

EXPIRATION DATE: June 28, 1969.

REASON FOR EXTENSION: By the terms of Mineral Extraction Lease P.R.C. 3520.1, the Lessee, Utah Construction & Mining Co., was required to open the mouth of the Russian River within nine months of date of lease issuance. The time limit was extended by subsequent Commission action through June 28, 1969. On December 14, 1966, the Commission authorized the issuance of Dredging Permit P.R.C. 3690.9, without payment of royalty, for the purpose of dredging an access channel to the area under lease. The term of that permit was also extended through June 28, 1969. The channel has not been cleared and additional time is required to complete the work.

OTHER PERTINENT INFORMATION:

- (a) All State agencies have approved project.
- (b) The U. S. Army Corps of Engineers has issued a permit which authorizes the dredging.
