## EXHIBIT "A"

A parcel of submerged land in Oakland Inner Harbor, within the City of Oakland, Alameda County, California, lying immediately adjacent to, and southerly of the property of Seatrain Lines, said parcel being more particularly described as follows:

BEGINNING at a point on the southerly property line of Seatrain Lines, having grid coordinates X = 1,481,063 and Y = 475,744, thence the following courses:
