CONVERSION OF PEFMITS TO PROSPECT FOR GEOTHERMAL RESOURCES UNDER THE GEOTHERMAL RESOURCES ACT OF 1967 - W.O. 6870.

Section 6919 of the Public Resources Code provides that any person who holds an unexpired permit to develop geothermal resources issued before the effective date of the Geothermal Resources Act of 1967 may convert it to a permit under the Act. The permittees listed in Exhibit "A" have applied for conversion and have complied with the provisions of the Act.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE CONVERSION OF THE PERMITS TO PROSPECT FOR GEOTHERMAL RESOURCES LISTED IN EXHIBIT "A" ATTACHED AND BY REFER-ENCE MADE A PART HEREOF UNDER THE GEOTHERMAL RESOURCES ACT OF 1967, BY ISSUING THE PERMIT FORM APPROVED ON MAY 29, 1969, IN EXCHANGE FOR THE ORIGINAL PERMIT FORM.
