18. SERVICE AGREEMENT FOR MAPPING AND DESCRIBING LAND TRANSFERRED TO CITY AND COUNTY OF SAN FRANCISCO PURSUANT TO CH. 1333/1968; SAN FRANCISCO PORT COMMISSION, ACTING BY AND FOR THE CITY AND COUNTY OF SAN FRANCISCO - W 8414.

After consideration of Calendar Item 17 attached, and upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION AUTHORIZES THE EXECUTIVE OFFICER TO EXECUTE A SERVICE AGREEMENT WITH THE SAN FRANCISCO PORT COMMISSION, ACTING BY AND FOR THE CITY AND COUNTY OF SAN FRANCISCO, IN THE AMOUNT OF \$10,000, FOR THE CONTINUANCE OF MAPPING AND DESCRIBING OF THE LANDS TRANSFERRED TO THE CITY AND COUNTY OF SAN FRANCISCO PURSUANT TO CHAPTER 1333, STATUTES OF 1968.

SERVICE AGREEMENT

CONTRACTEE: San Francisco Port Commission, acting by and for the City and County of San Francisco.

GRANTEE: City and County of San Francisco.

LOCATION: All right, title, and interest to lands formerly held by the State of California and acquired by virtue of its sovereignty or otherwise, other than minerals, located in the City and County of San Francisco and presently under the jurisdiction of the San Francisco Port Commission (formerly the Harbor Commission of the City and County of San Francisco), together with all improvements, rights, privileges, easements, and appurtenances connected therewith or any way appertaining thereto.

PURPOSE: Section 2 of Chapter 1333, Statutes of 1968, as amended by Chapter 670, Statutes of 1970, provides as follows:

"In lieu of any survey which might otherwise be required by law, within three years after the effective date of this act, the State Lands Commission shall, at the cost of the Port Commission of the City and County of San Francisco, provide a description of the transferred lands, using such references and designations as are commonly known place names and geographical and political boundaries, and surveying and monumenting only when known designations or points of reference are not available. The description so prepared and a plat thereof shall thereafter be recorded by the State Lands Commission in the office of the Recorder of the City and County of San Francisco."

So that reimbursements may be received by the State Lands Commission for completion of its work in connection with the survey of the property transferred under Chapter 1333, Statutes of 1968, a supplementary service agreement must be entered into between the City and County of San Francisco, acting through the San Francisco Port Commission, and the State Lands Commission, to supplement the agreement approved by the State Lands Commission at its meeting April 23, 1970, Minute Item #26.

TERMS AND

CONDITIONS: This contract in the amount of \$10,000 is for continued work in connection with the survey, mapping and description of the lands transferred to the City and County of San Francisco pursuant to Chapter 1333, Statutes of 1968, as amended by Chapter 670, Statutes of 1970.
