22. RATIFICATION OF EMERGENCY DREDGING PERMIT AND ISSUANCE OF  
A MAINTENANCE DREDGING PERMIT, MENDOCINO COUNTY - W 9960,  
PRC 5149.

After the Commission meeting a typographical error was noted  
in Recommendation No. 3 of the Calendar Item. The estimated  
number of cubic yards to be dredged was typed "25,000"; how-  
ever the amount should be "2,500" cubic yards. This Minute  
Item reflects that correction.

Upon motion duly made and carried, the following resolution was  
adopted by a vote of 3 to 0:

THE COMMISSION:

1. DETERMINES THAT AN ENVIRONMENTAL IMPACT REPORT HAS NOT BEEN  
PREPARED FOR THIS ACTIVITY AS SUCH REPORT IS NOT REQUIRED  
UNDER THE PROVISIONS OF PUBLIC RESOURCES CODE 21172; 14  
CAL. ADM. CODE 15071; AND 2 CAL. ADM. CODE 2903(D),  
(EMERGENCY PROJECTS).
2. RATIFIES THE EXECUTION OF AN EMERGENCY DREDGING PERMIT  
ISSUED PURSUANT TO LETTER DATED MAY 28, 1976, SAID PERMIT  
IS ON FILE WITH THE OFFICE OF THE STATE LANDS DIVISION  
AND BY REFERENCE MADE A PART HEREOF.
3. AUTHORIZES THE ISSUANCE OF PERMIT TO MR. L. W. GRAVES TO  
DREDGE AN ESTIMATED 2,500 CUBIC YARDS, 500 CUBIC YARDS  
ANNUALLY FOR 5 YEARS, FROM APPROXIMATELY 0.27 ACRES OF  
TIDE AND SUBMERGED LANDS IN THE NOYO RIVER, MENDOCINO  
COUNTY; SUCH AREA BEING DESCRIBED IN EXHIBIT "A" ATTACHED  
AND BY REFERENCE MADE A PART HEREOF; AT A ROYALTY OF  
\$0.25 PER CUBIC YARD, AND TO SPOIL SUCH MATERIAL ON PRIVATE  
UPLANDS, EFFECTIVE JUNE 24, 1976, TO DECEMBER 31, 1981;  
SUCH PERMISSION TO BE SUBJECT TO THE ISSUANCE OF A  
CALIFORNIA DEPARTMENT OF FISH AND GAME PERMIT, CERTIFICA-  
TION BY THE CALIFORNIA REGIONAL WATER QUALITY CONTROL  
BOARD, AND A U. S. CORPS OF ENGINEERS PERMIT, AND TO ALL  
OTHER REQUIREMENTS, RECOMMENDATIONS OR LIMITATIONS AS  
SET OR AS MAY BE SET BY STATE, FEDERAL OR LOCAL GOVERN-  
MENTS.

RATIFICATION OF EMERGENCY DREDGING PERMIT AND THE  
ISSUANCE OF A MAINTENANCE DREDGING PERMIT

On April 23, 1976, the State Lands Division received an application from Mr. Thomas W. Griffiths, representing Mr. L. W. Graves of the Dolphin Cove Marina, Mendocino County, requesting a permit to perform annual maintenance dredging of 500 cubic yards of material per year plus permission to do an immediate emergency dredging of 500 cubic yards from an existing shoal in the channel serving Dolphin Cove Marina at the Noyo River, Mendocino County. The portion of the river to be dredged is in a grant to the Noyo Harbor District with minerals reserved. Commercial and pleasure craft have grounded on the shoal and required the assistance of the Coast Guard to be freed. The traffic in the navigable channel will increase with the approach of summer. Mr. Graves has submitted the required fees and information with his application. A royalty of \$0.25 shall be levied for removal of minerals from State land. An emergency letter permit was issued to Mr. L. W. Graves by Mr. W. F. Northrop, Executive Officer. This project is categorically exempt under CEQA Guidelines Section 2903(d), Title 2, California Administrative Code.

W 996C

A parcel of submerged land in the State owned bed of the Hoyo River, Mendocino County, California, situated in section 18, T 18 N, R 17 W, M.D.M., more particularly described as follows:

COMMENCING at point designated E 62 using California coordinate system Zone 2, coordinates of  $x=1,492,912$  and  $y=646,511$ , as shown on a California State Lands Commission map representing a survey of the ordinary high water mark of the Hoyo River, dated June, 1954 and filed in map case 1, drawer 10, page 4, Mendocino County records; thence N  $5^{\circ}$  W, 25 feet to the TRUE POINT OF BEGINNING; thence N  $36^{\circ}$  E, 220 feet; thence N  $54^{\circ}$  W, 70 feet; thence S  $36^{\circ}$  W, 220 feet; thence S  $54^{\circ}$  E, 70 feet to the point of beginning.

The bearings in this description are based on the California Coordinate System Zone 2.
