DREDGING PERMIT

APPLICANT: City of Sacramento  
Department of Parks and Recreation  
3520 Fifth Avenue  
Sacramento, California 95817

PROPOSED DREDGING: Perform maintenance dredging (35,000 cubic yards total) of silt from Sacramento Boat Harbor at Miller Park adjacent to the Sacramento River, Sacramento County, more particularly described in Exhibit "A".

SPOILS PLACEMENT: Material will be pumped across the Sacramento River through an existing pipe in the levee for disposal in the Port of Sacramento spoil area which is directly southwest of the entrance to Sacramento Boat Harbor at Miller Park.

OWNERSHIP: The proposed dredge area is located entirely within lands granted to the City of Sacramento pursuant to Chapter 1266, Statutes of 1970, as amended by Chapter 625, Statutes of 1973, with the minerals reserved to the State. The disposal site is owned by the Sacramento Yolo Port District.

The City of Sacramento has a non-exclusive license with the Sacramento Yolo Port District to use their disposal site and in return they give up any right to the disposed material.

PURPOSE: Designed as a major cleanup of the entry and perimeter docking areas of the Sacramento Boat Harbor. It is anticipated that the project will not have to be repeated for another 15 or 20 years.

CONSIDERATION: The public interest, no royalty required. Material will be used primarily as levee fill by the Sacramento Yolo Port District.

ENVIRONMENTAL IMPACT CONSIDERATION: No Environmental Impact Report is required for project. This project is within the purview of 2 Cal. Adm. Code 2907, Class 4, which exempts a maintenance dredging operation.

OTHER PERTINENT INFORMATION:

1. Applicant has received the approval and/or permits from the following agencies:
  - A. California Regional Water Quality Control Board, Central Valley Region.
  - B. Department of Fish and Game with stipulations as follows:
    - a. Work be confined to the period August 31, 1976 to August 31, 1977.
    - b. Work to be done in the manner specified by the operator's letter of May 5, 1976, to Mr. Paul Giguere of Department of Fish & Game and signed by Mr. Gene Robinson.
  - C. State Reclamation Board Permit #11655.
  - D. U.S. Army Corps of Engineers Permit #5942.
2. Effective period of the permit shall be from August 26, 1976. to August 31, 1977.

IT IS RECOMMENDED THAT THE COMMISSION:

1. DETERMINE THAT AN ENVIRONMENTAL IMPACT REPORT HAS NOT BEEN PREPARED FOR THIS MAINTENANCE DREDGING PROJECT AS SUCH REPORT IS NOT REQUIRED UNDER THE PROVISIONS OF TITLE 2, SECTION 2907, CALIFORNIA ADMINISTRATIVE CODE.
2. AUTHORIZE THE ISSUANCE OF A PERMIT TO THE CITY OF SACRAMENTO, DEPARTMENT OF RECREATION AND PARKS TO DREDGE APPROXIMATELY 35,000 CUBIC YARDS OF MATERIAL FROM THE SACRAMENTO BOAT HARBOR ENTRANCE AND PERIMETER BERTHS ADJACENT TO THE SACRAMENTO RIVER (MILE 56.9), SACRAMENTO, SACRAMENTO COUNTY, SUCH AREA BEING DESCRIBED IN EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF; AND TO SPOIL SUCH DREDGED MATERIAL AT THE SACRAMENTO YOLO PORT DISTRICT DISPOSAL AREA; EFFECTIVE FROM AUGUST 26, 1976 TO AUGUST 31, 1977; SUCH PERMIT TO BE CONDITIONAL UPON THE ISSUANCE AND REQUIREMENTS OF A PERMIT FROM THE U.S. ARMY CORPS OF ENGINEERS AND ANY OTHER PERMIT, REQUIREMENTS, OR LIMITATIONS AS SET OR AS MAY BE SET BY FEDERAL, STATE OR LOCAL GOVERNMENT.
