DREDGING PERMIT

APPLICANT:

City of Richmond

City Hall

Richmond, California 94804

PROPOSED DREDGING:

To perform dredging of approximately 10,000 cubic yards of material from an area (described in Exhibit "A" attached), of tide and submerged granted lands, adjacent to Terminal No. 1 in Richmond Harbor, Richmond, Contra Costa County.

SPOILS PLACEMENT:

All spoils to be transported by bottom dump barge to San Francisco Disposal Site 11, Alcatraz Island. This is a Corps of Engineers approved site.

OWNERSHIP:

Dredge area is within grant to the City of Richmond with minerals reserved to the State of California.

CONSIDERATION: Public benefit, no royalty required.

ENVIRONMENTAL IMPACT CONSIDERATION:

- 1. An Environmental Impact Report is not required. This project is within the purview of 2 Cal. Adm. Code 2907, Class 4, which exempts maintenance dredging operations.
- 2. This project is situated on State land identified as possessing significant environmental values, pursuant to Public Resources Code 6370.1, and is classified in a significant use category, Class C: Multiple Use.

Staff review indicates that there will be no significant effect upon the identified environmental values. The staff of the Division has received no adverse comments on this project.
