DREDGING PERMIT

APPLICANT:

County of Sonoma 2555 Mendocino Avenue

Santz Rosa, California 95401

PROPOSED DREDGING:

The proposed project is to remove an existing dike which will involve the removal of approximately 3,000 cubic yards of sand, clay and topsoil from an area of sovereign lands within Bodega Bay, Sonoma Gounty.

SPOILS PLACEMENT:

The material will be removed by carryall and placed on County-owned uplands northerly from and adjacent to the dike area.

OWNERSHIP:

The removal area is within an area granted to the County of Sonoma (Stats. 1951), with minerals reserved to the State.

PURPOSE:

To remove an obstruction (the dike) which prevents the full tidal action in order to rejuvenate the existing marsh area behind the dike.

CONSIDERATION:

Public benefit, no royalty required.

ENVIRONMENTAL CONSIDERATION:

- 1. The County of Sonome, lead agency, has processed a negative declaration for the project, on file with the office of the State Lands Commission and by reference made a part hereof. The County states that the requirements of CEQA have been fulfilled.
- 2. This project is situated on State land identified as possessing significant environmental values, pursuant to Public Resources Code 6370.1, and is classified in a significant use category, Class B: Limited Use. Staff review indicates that there will be no significant detrimental effect upon the identified environmental values. The staff of the Division has received no adverse comments on this project.

The permit will be issued contingent upon the applicant securing permission from those agencies.

- The upland area to receive the spoils is diked to prevent runoff from returning to the waterway.
- Effective period of the permit to be January 26, 1977 to December 31, 1977.
