East Bay Regional Park District 11500 Skyline Boulevard Oakland, California 94619

AREA, TYPE LAND AND LOCATION:

Approximately 55.5 acres in three parcels between Pinole and Hercules, Contra Costa County.

LAND USE:

Public park and recreation area including trails, interpretive stations and appurtenant structures.

TERMS OF PROPOSED LEASE:

Initial period: 49 years from March 1, 1977.

Public liability insurance: \$5,000,000.

CONSIDERATION:

The public use and benefit, with the State reserving the right at any time to set a monetary rental if the Commission finds such action to be in the State's best interest.

PREREQUISTTE TERMS, FEES AND EXPENSES:

Eiling fee and processing costs have been received.

STATUTORY AND OTHER REFERENCES:

A. Public Resources Code: Div. 6, Parts 1 & 2.

OTHER PERTINENT INFORMATION:

- 1. The annual rental value of the site is estimated to be in excess of \$56,000.
