SEVENTH MODIFICATION OF THE 1976-1977 PLAN OF DEVELOPMENT AND OPERATIONS AND BUDGET, LONG BEACH UNIT, WILMINGTON OUL FIELD, LOS ANGELES COUNTY

The City of Long Beach has requested Commission approval of the Seventh Modification of the 1976-1977 Plan of Development and Operations and Budget for the Long Beach Unit. This modification transfers \$698,000 of existing funds within the Budget to provide for the construction of 22 additional well cellars on Island Freeman. The total Long Beach Unit Budget of \$75,876,000 remains unchanged.

The 1976-1977 Plan contemplated the construction of additional cellars on Island Freeman; however, funding was not included in the Budget because the development drilling program was uncertain at the time the Budget was prepared. Current review of the development drilling program indicates that the construction of 22 additional well cellar locations are now economically justified.

After approval of this Seventh Modification the affected Budget Ttems will be adjusted as follows:
