GENERAL LEASE - RIGHT OF WAY USE

APPLICANT:

Pacific Gas and Electric Company 77 Beale Street San Francisco, California 94106

AREA, TYPE LAND AND LOCATION:

A 1,37% acre parcel of submerged land in the Sacramento River near Anderson, Shasta County.

LAND USE:

For construction and maintenance of one 12 KV overhead electrical crossing; and maintenance or one 115 KV overhead ellectrical crossing.

TERMS OF PROPOSED DEASE.

Initial period: 15 years from April 1, 1977.

Renewal options: 3 successive periods of 10 years, each

CONSIDERATION: \$100 per annum with the Stars reserving the right to fix a different rental on each fifth

anniversary of the lease.

BASIS FOR CONSIDERATION:

\$100 minimum rental for this type of lease.

PREREQUISITE TERMS, FEES AND EXPENSES:

applicant is permittee of upland.

Falling fee and environmental costs have been received.

STATUTORY AND OTHER REFERENCES:

A: Public Resources Code; Div. 6, Parts 1 & 2.

- 3. FIND THAT GRANTING OF THE LEASE WILL HAVE NO SIGNIFICANT EFFECT UPON ENVIRONMENTAL CHARACTERISTICS IDENTIFIED PURSUANT TO SECTION 6370.1, OF THE PUBLIC RESOURCES CODE.
- AUTHORIZE ISSUANCE TO PACIFIC GAS AND ELECTRIC COMPANY OF A 15 YRAR GENERAL LEASE - RIGHT OF WAY USE FROM APRIL 1, 1977; WITH LESSEE'S OPTION TO RENEW FOR 3 SUCCESSIVE PERIODS OF 10-YEARS EACH: IN CONSIDERATION OF ANNUAL RENT IN THE AMOUNT OF \$100 WITH THE STATE RESERVING THE RIGHT TO FIX A DIFFERENT RENTAL ON EACH FIFTH ANNIVERSARY OF THE LEASE; IF THE STATE LANDS COMMISSION ADOPTS RULES AND REGULATIONS WHICH BECOME EFFECTIVE BEFORE AUGUST 1, 1978 CONCERNING PROVISIONS FOR WHEELING ELECTRICAL POWER ON BEHALF OF OTHER AGENCIES ACROSS STATE TIDE AND/OR SUBMERGED LANDS AND SCHOOL LANDS, SUCH PROVISIONS SHALL BE APPLICABLE TO THIS LEASE AS IF SET FORTH HEREIN IN FULL; FOR CON-STRUCTION AND MAINTENANCE OF ONE 12 KV OVERHEAD ELECTRIC CROSSING AND APPURTENANCÉS THERETO; MAINTENANCE OF ONE 115 KV OVERHEAD ELECTRIC CROSSING AND APPURTEDANCES THERETO ON THE LAND DESCRIBED ON EXHIBIT "A" ATTY CHED AND BY REFERENCE MADE A PART HEREOF.
