An Environmental Impact Report is not required. This transaction is within the purview of 2 Cal. Adm. Code 2907(a) 2. which exempts an existing structure or facility that is in an acceptable state of repair and there is no evidence of record to show injury to adjacent property, shoreline erosion, or other types of environmental degradation.
