2. A final EIR was prepared by Sacramento Regional County Sanitation District, pursuant to CEQA and implementing regulations. A Notice of Determination has been received.
3. This project is situated on State land identified as possessing significant environmental values pursuant to Public Resources Code 6370.1, and is classified in a use category, Class A, which authorizes Restricted Use.

Staff has coordinated this project with those agencies and organizations who nominated the site as containing significant environmental values. They have found this project to be compatible with their nominations.

4. Special provisions are contained within this permit which provide for a temporary easement for construction purposes. The special provisions also provide for the termination of this right upon completion of construction of the authorized improvement, or January 1, 1980 which ever shall occur first.

Reclamation Board - October, 1977; Corps of Engineers - November, 1977; Caltrans - October, 1977; Air Pollution Control Board - August, 1977; Water Quality - September, 1977; Fish and Game - October, 1977.
