ASSIGNMENT OF PUBLIC AGENCY PERMIT

BACKGROUND:

The Commission at the March 31, 1977 meeting approved a 66-year Public Agency Permit to the Wi'dlife Conservation Board and/or the County of San Diego for a parcel of land in San Elijo Lagoon, San Diego County. This permit. PRC 5328.9, was generated as part of an agreement for the settlement of title claims, and the establishment of a boundary between State and private ownership. Subsequent to this approval the staff executed the 66-year permit with the Wildlife Conservation Board, beginning June 1, 1977, designated as PRC 5328.9.

CURRENT SITUATION:

The Commission's staff has now been informed by the Wildlife Conservation Board and the Department of Fish and Game that the permittee should be the Department of Fish and Game. This action is necessary because Fish and Game will be the agency actually involved in administering the permit area. There is the possibility that the County of San Diego may eventually work out a cooperative agreement with Fish and Game for the management of San Elijo Lagoon.

OTHER PERTINENT INFORMATION:

 An environmental document is not required. The public agency permit is within the purview of Section 21065, 14 Cal. Adm. Code 15037 and 2 Cal. Adm. Code 2903 which exempts activities which are a non-project under CEQA. The Commission in authorizing this permit at its meeting on March 31, 1977 made the appropriate environmental findings.
