APPROVAL OF CONTRACT WITH COUNTY OF ORANGE

The Environmental Management Agency of the County of Orange has requested the State Lands Commission to enter into a contract with the County to conduct an engineering and geological evaluation of the oil and gas field and facilities in the Bolsa Chica area. The subsequent findings shall be provided to the County in a report entitled "Forecasting of Energy Production and Oil and Gas Facility Relocation in the Bolsa Chica Area, Orange County". The County agrees to pay the State for reimbursable expenses up to a total of \$9,100 for the service.

The staff will perform the study based on data currently on file with the Commission and from several operators who will share data on wells, facilities, and pipeline locations in the study area. State Oil and Gas Lease PRC 4736 and the onshore well locations for State Oil and Gas Lease PRC 426, both operated by Aminoil USA, Inc., are located within the study area.

The Orange County Board of Supervisors authorized the Director of the Environmental Management Agency, to enter into such contract on December 5, 1978. The Director executed the contract on November 20, 1979, and, following Commission approval, the contract will be forwarded to the State Department of General Services and Orange County General Services Agency for execution.

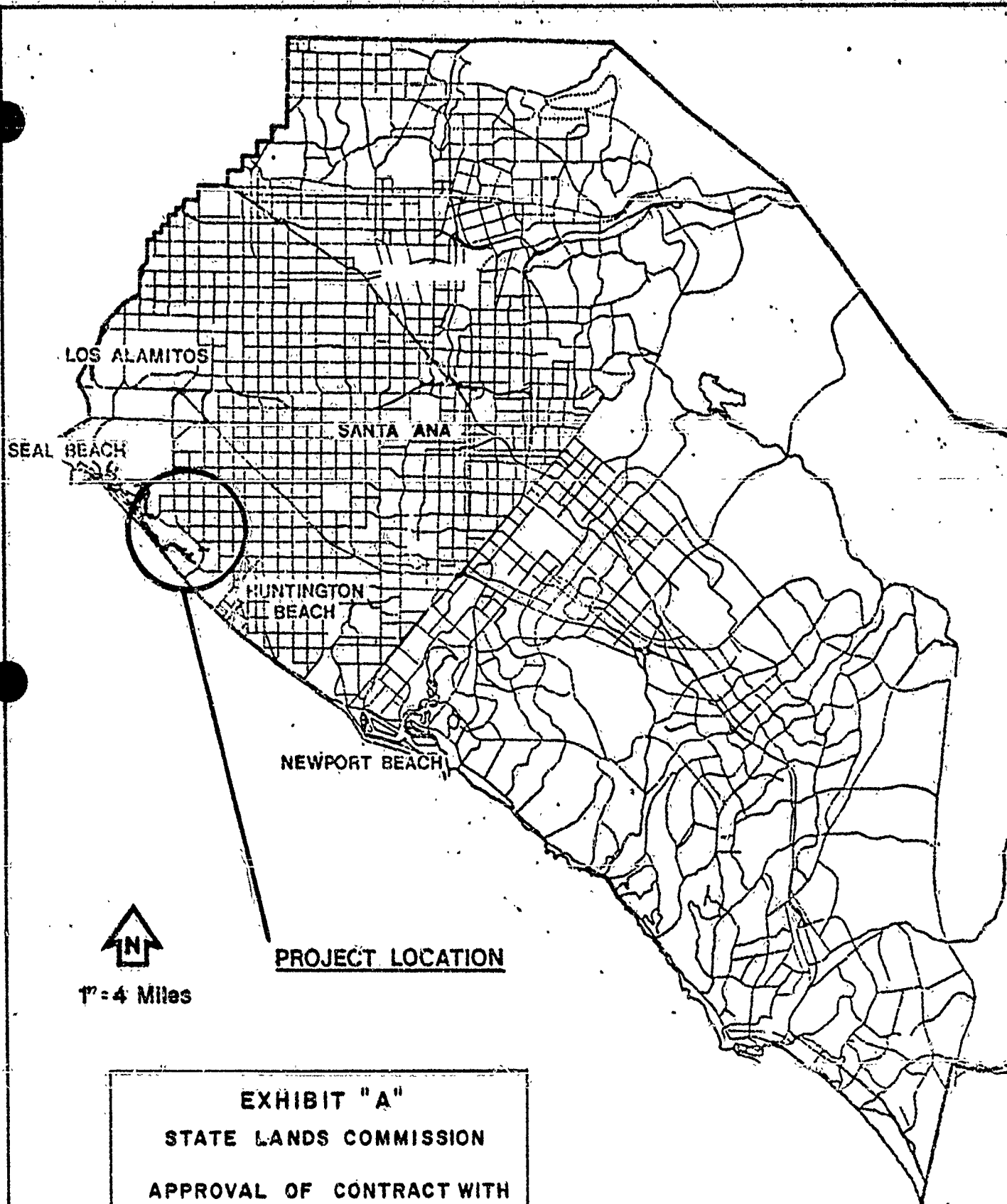
EXHIBIT: A. Location Map.
