AUTHORIZE ISSUANCE 10 SHELL OIL COMPANY OF A 30-YEAR REPLACEMENT GENERAL LEASE, RIGHT-OF-WAY USE, FROM APRIL 29, 1980; IN CONSIDERATION OF ANNUAL VOLUMETRIC RENT IN THE AMOUNT OF \$0.0025 PER 42 GALLON BARREL, WITH A BASE ANNUAL RENT IN THE AMOUNT OF \$1875, WHICHEVER IS GREATER, WITH THE STATE RESERVING THE RIGHT TO FIX A DIFFERENT RENTAL ON EACH TENTH ANNIVERSARY OF THE LEASE; PROVISION OF A \$50,000 SURETY BOND; PROVISION OF PUBLIC LIABILITY INSURANCE IN THE AMOUNT OF \$2,000,000 PER OCCURRENCE FOR BODILY INJURY AND PROPERTY DAMAGE, COMBINED COVERAGE, FOR THE OPERATION AND MAINTENANCE OF A PETROLEUM PRODUCTS 10-INCH DIAMETER PIPELINE, ON THE LAND DESCRIBED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.
- 5. PROVIDE IN THE LEASE FOR THE IMPOUNDING OF VOLUMETRIC RENTAL IN EXCESS OF THE MINIMUM ANNUAL RENTAL PENDING THE OUTCOME OF EXISTING LITIGATION CONCERNING THE VALIDITY OF THE COMMISSION'S VOLUMETRIC RENTAL REGULATIONS.
