GENERAL LEASE -- COMMERCIAL USE

APPLICANT: Gerald Morton  
P. O. Box 33  
Newport, Oregon 97365

AREA, TYPE LAND AND LOCATION:  
A 0.092-acre parcel of tide and submerged  
land located in the Klamath River, one-fourth  
mile west of the Highway 101 Bridge,  
Del Norte County.

LAND USE: Seasonal boat marina and routine maintenance  
dredging.

TERMS OF PROPOSED LEASE:  
Initial period: 20 years from November 12,  
1980.  
Surety bond: \$2,000.  
Public liability insurance: Combined single  
limit coverage of \$200,000.

CONSIDERATION: \$225 per annum with the State reserving  
the right to fix a different rental on  
each fifth anniversary of the lease.

BASIS FOR CONSIDERATION:  
Pursuant to 2 Cal. Adm. Code 2005.

PREREQUISITE TERMS, FEES AND EXPENSES:  
Applicant is owner of upland.

Filing fee has been received.

OTHER PERTINENT INFORMATION:

1. The 0.092-acre parcel of tide and submerged land in the Klamath River contains seasonal floating docks to accommodate the Sportsman RV Park consisting of 72 recreational vehicle parking sites purchased by Gerald Morton, the applicant, in August, 1980. The lease also calls for routine maintenance dredging of the channel connecting the boat marina with the mainstream of the Klamath River. A previous permit for dredging was issued effective through December 31, 1980.
2. An EIR is not required. This transaction is within the purview of 2 Cal. Adm. Code 2907, Class 1(B), which exempts an existing structure or facility that is an acceptable state of repair and there is no evidence of record to show injury to adjacent property, shoreline erosion, or other types of environmental degradation and by Class 4(D) which permits minor periodic maintenance dredging for existing docks and marinas.
3. This project is situated on State land identified as possessing significant environmental values pursuant to P.R.C. 6370.1, and is classified in a use category, Class A, which authorizes Restricted Use. Staff has coordinated this project with those agencies and organizations who nominated the site as containing significant environmental values. They have found this project to be compatible with their nomination.

2. DETERMINE THAT THE PROJECT IS CONSISTENT WITH THE PROVISIONS OF ARTICLE 6.5, OF TITLE 2, OF THE CAL. ADM. CODE.
3. FIND THAT GRANTING OF THE LEASE WILL HAVE NO SIGNIFICANT EFFECT UPON ENVIRONMENTAL CHARACTERISTICS IDENTIFIED PURSUANT TO SECTION 6370.1, OF THE P.R.C.
4. AUTHORIZE ISSUANCE TO GERALD MORTON OF A 20-YEAR GENERAL LEASE - COMMERCIAL USE FROM NOVEMBER 12, 1980; IN CONSIDERATION OF ANNUAL RENT IN THE AMOUNT OF \$225, WITH THE STATE RESERVING THE RIGHT TO FIX A DIFFERENT RENTAL ON EACH FIFTH ANNIVERSARY OF THE LEASE; PROVISION OF A \$2,000 SURETY BOND; PROVISION OF PUBLIC LIABILITY INSURANCE FOR COMBINED SINGLE LIMIT COVERAGE OF \$200,000; FOR A SEASONAL BOAT MARINA OPERATION AND ROUTINE MAINTENANCE DREDGING ON THE LAND DESCRIBED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.

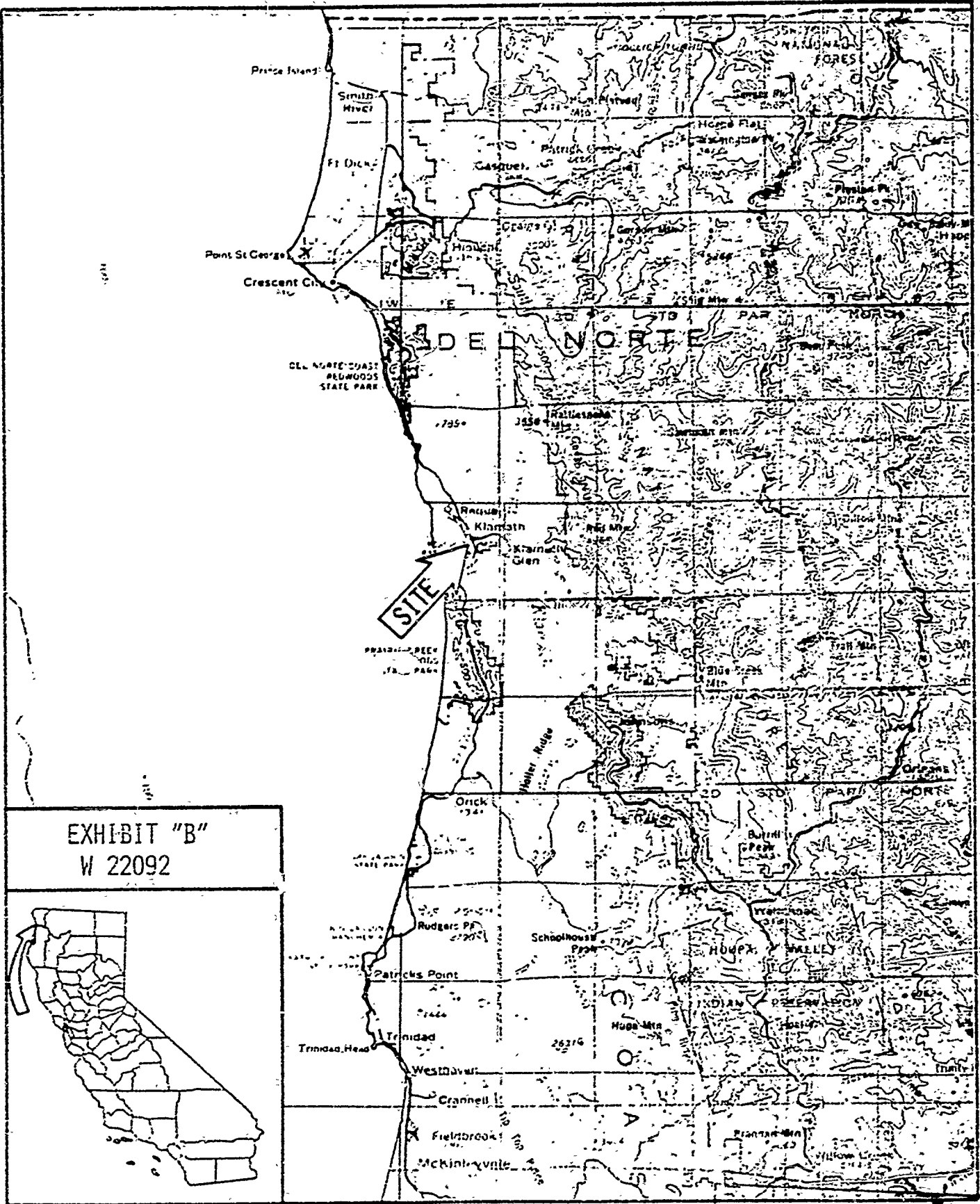
