AMENDMENT OF FUELBREAK AGREEMENT - PRC 5813.9

The State Lands Commission authorized Fuelbreak Agreement -PRC 5813.9 with the United States Department of Agriculture, Forest Service at its meeting in April, 1980 (Minute Iter No. C2, April 24, 1980). The Commission in consideration of the benefits to the State school land under its jurisdiction consented to the construction and maintenance of a fuelbreak by the Forest Service. The Agreement permitted a fuelbreak 200 feet in width across school land in the NWA NEZ, Section 36, T9S, R23E, MDM, in Fresno County. Its term commenced 4/24/80, for a ten year period, and terminates April 23, 1990.

In late July, 1981 the Forest Service applied to amend Fuelbreak Agreement - PRC 5813.9 to include prescribed burning on the 28-acre portion of the subject NW2 NEZ, lying northeasterly of the existing fuelbreak. The term of the prescribed burning amendment was requested to have a termination date of April 23, 1990 common with the Fuelbreak Agreement. The Forest Service has planned a 350-acre helitorch prescribed burn on adjacent National Forest land, as parts of their continuing fuel reduction program in Jose Basin, vicinity of the highly developed Shaver Lake area. The burn will be on a opportunity basis in 1981-82. The fuelbreak on the school land is an integral part of the control line for this 350-acre burn project. The 28-acres of school land upor which prescribed burning authorization is desired by the Forest Service lies between the fuelbreak and the National Forest land. Inclusion of prescribed burning of the 28-acres will provide a continuous area totalling 2,000 acres where highly flammable chaparral vegetative cover will have been treated.

The Forest Service will artifically seed burned areas with annual/perennial grasses, as needed, if it is determined that insufficient natural seed exists. Periodic treatment of fuels to maintain fuel loading at a moderate level is planned. Additional benefiles: (1) A public need will be served by reducing the severity of wildfires and, also, protecting State and private property and resource values; and (2) It is viewed, direct benefits will accrue to wildlife populations and diversity as a result of the prescribed burn project on all lands preated.

The proposed amendment of Fuelbreak Agreement - PRC 5811.9 does not convey any interest in real property; it provides a cooperative arrangement whereby the State contributes a portion of its land and the Forest Service will conduct prescribed burning, artificial seeding of grasses and perfodic treatment of fuels upon a portion thereof.

The existing Exhibits "A-1" and "A-2" in the original agreement are deleted and new Exhibits "B-1" and "B-2" substituted therefore in the amended agreement. Said Exhibits "B-1" and "B-2" are attached.

All other terms and conditions of the original Agreement shall remain unchanged and in full force and effect.

- 1. This project is exempt from CEQA because it is an action by a regulatory agenby for protection of the environment. Authority: 14 Cal. Adm. Code, Div. 5, Section 15108.
- 2. This project is situated on State land identified as possessing significant environmental values pursuant to PRC 6370.1, and is classified in a use category, Class B, which authorized Limited Uses
- 3. Staff has coordinated this project with those agencies and organizations which nominated the site as containing significant environmental values. They have found this project to be compatible with their nomination.
- 4. The proposed Amendment of Fuelbreak Agreement - PRC 5813.9 has been reviewed and approved by staff of the Commission. A copy of the proposed amendment is on file in the Office of the State Lands Commission.

PARCEL 1

DESCRIPTION OF THE FUELBREAK LOCATION AND MAINTENANCE AREA

A strip of land 200 feet wide, for maintenance area and fire fuelbreak purposes in the NWŁ NEŁ of Section 36, T9S, R23E, MDM, in the County of Fresno, State of California, containing an area of 6.8 acres more or less, said strip lying 100 feet on each side of the following described centerline:
