- 1. The applicant requests renewal of its lease pursuant to its terms to provide electric power service to Schenkel's Island. The lease is being amended to current Commission standards and the leased right-of-way width is being reduced from 100 feet to 20 feet. The area is being reduced from 0.516 acre to 0.087 acre.
- 2. This project is exempt from CEQA because it is an existing structure, 2 Cal. Adm. Code Section 2905, Class 1.
- 3. The activity is located on lands not identified as having significant environmental values under PRC 6370.
