OTHER PERTINENT INFORMATION:

1. Except in Huntington Harbour, EIRs are not required in that the existing facilities are in an acceptable state of repair; or are boat mooring buoys not used for commercial purposes.

2. The individual projects are situated on State land identified as possessing significant environmental values pursuant

to P.R.C. 6370.1, and are classified in use categories, Classes B or C, which authorizes Limited or Multiple Use, or are situated on other lands identified as possessing environmental values as stated in December 1, 1975 State Lands Commission meeting. Staff review indicates that there will be no significant effect on identified environmental values.

3. Lake Tahoe Application: The Commission at its meeting on November 27, 1978 suspended all leasing for new construction at Lake Tahoe, except for mooring buoys in designated areas. This action was taken pending completion of an EIR which addresses the cumulative impact of continued construction of piers in Lake Tahoe. Application W 22865 herein is for the continued use of existing buoys in the lake, and therefore is not subject to the Commission's suspension of leasing activities for new construction.

W 22595 proposes placement of one mooring buoy which is to be placed in an area not identified by the California Department of Fish and Game as a prime fish habitat area, a significant spawning area, or a marsh. Staff has coordinated this proposed buoy placement with appropriate agencies; no adverse comments were received.

4. Permits covering structures in Lake
Tahoe will include a condition subsequent
that if any structure authorized is
found to be in nonconformance with
the Tahoe Regional Planning Agency's
Shorezone ordinance and if any alterations,
repairs, or removal required pursuant
to said ordinance are not accomplished
within the designated time period,
then the permit will be automatically
terminated, effective upon notice by
the State and the site shall be cleared
pursuant to the terms thereof.

5. Recreational piers in Huntington harvour have been found to pose no significant adverse environmental effects (cumulative FIR by City). The area has been found capable of accommodating the development. A cumulative EIR for Huntington Harbour was approved by the State Lands Commission at its March 25, 1976 meeting. The impact of the specific projects were included in this cumulative report.

- 1. DETERMINE THAT EIRS HAVE NOT BEEN PREPARED FOR THESE ACTIVITIES, EXCEPT AT HUNTINGTON HARBOUR, AS SUCH REPORTS ARE NOT REQUIRED UNDER THE PROVISIONS OF P.R.C. 21084, 14 CAL. ADM. CODE 15100, ET SEQ., AND 2 CAL. ADM. CODE 2905; AND THAT ALL THE ACTIVITIES ARE COMPATIBLE WITH THEIR RESPECTIVE LAND USE CLASSIFICATION.
- 2. DETERMINE THAT THE FACILITIES IN HUNTINGTON HARBOUR HAVE BEEN DISCUSSED IN A CUMULATIZE EIR AND FOUND NOT TO HAVE A SIGNIFICANT EFFECT ON THE ENVIRONMENT.
- 3. AUTHORIZE THE ISSUANCE OF TEN-YEAR RECREATIONAL PIER PERMITS TO THE APPLICANTS LISTED IN EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.
