DREDGING PERMIT

In accordance with the Commission's Delegation of authority to the Executive Officer on February 24, 1977, (Minute Item 32) to issue dredging permits of 10,000 cubic yards or less, to perform maintenance dredging on State-owned lands, the following applicant has been granted such permission.

The permit provides for excavating a maximum of 3,200 cubic yards of shoreline sediments, excluding all other minerals including but not limited to oil, gas, and geothermal, from granted submerged lands (minerals reserved) in the bed of Lake Tahoe, Placer County, California. Dredging is required to remove sediments deposited within the harbor area and breakwater of the Fleur du Lac Yacht Club, to facilitate safe navigation.

Spoils will be placed on an upland private disposal area. The permit provides for a royalty of \$0.25 per cubic yard for materials placed on private property or sold and is effective from February 1, 1982 through January 31, 1983.

A littoral monitoring program will be implemented for a one-year period during the dredging operation. Wind monitoring will be carried out continuously, with retrieval of data monthly by State Lands Commission staff as will a waterline check, a water depth check, and a lake water level check, with the dates of data collection included (Exhibit C).

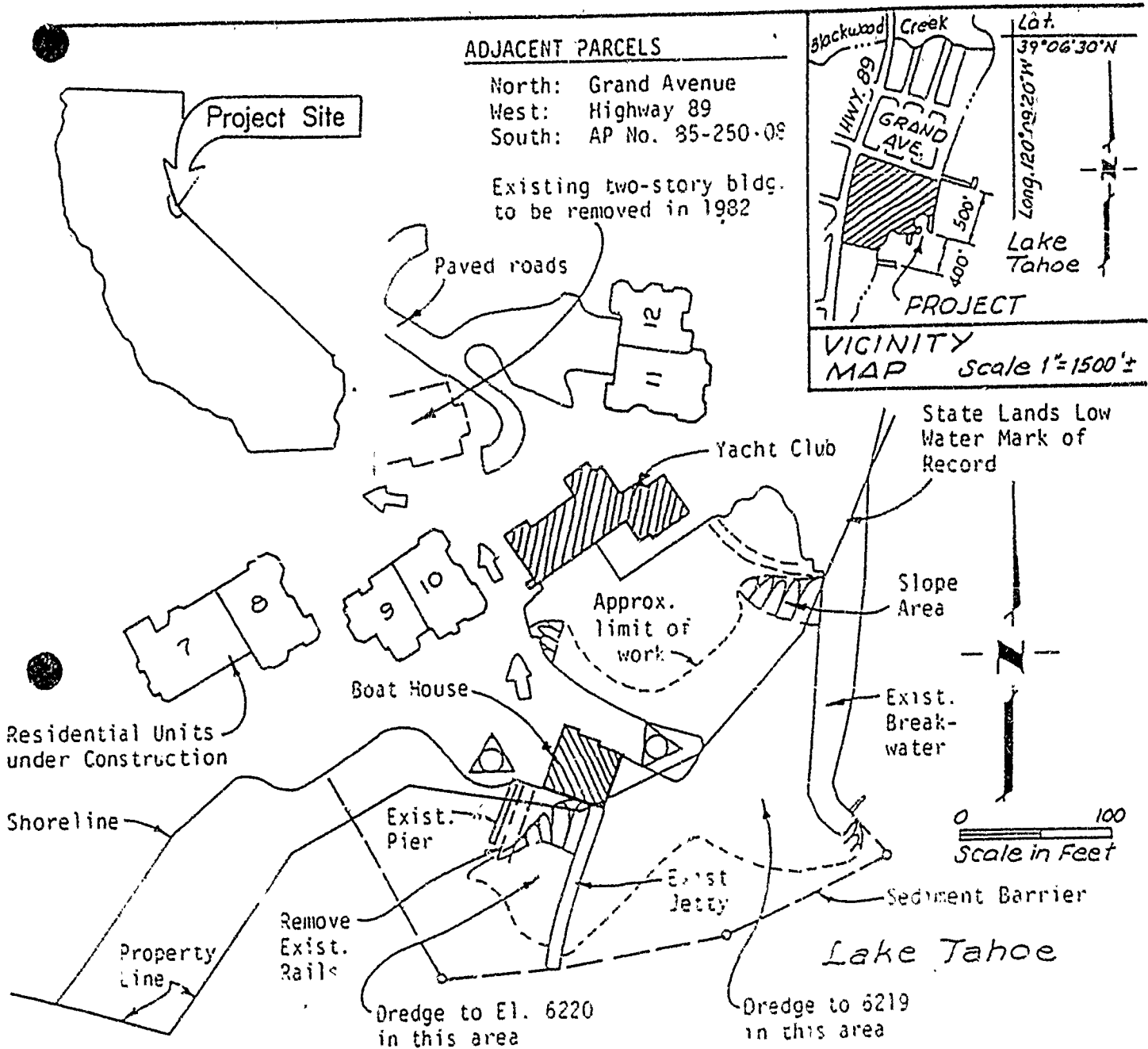

CALENDAR ITEM NO. 619 (CONTD)

1. The proposed project is categorically exempt from the requirements of the CEQA guidelines as maintenance dredging with spoils disposal in an approved upland disposal area.
2. Issuance of the permit and the resultant project will have no significant adverse effect on the environment or the environmental characteristics identified pursuant to Section 6370.1 et seq. of the P.R.C.
3. The dredging amount will not exceed 10,000 cubic yards.
4. A charge per cubic yard will be assessed for spoil material that is deposited on private property or otherwise lost to future State benefit.
5. A littoral monitoring program shall be implemented to record wind data, waterline movement, water depth and lake level data in the vicinity of the project.
6. Approval of the project will be contingent upon approval by all pertinent State, federal and local agencies.

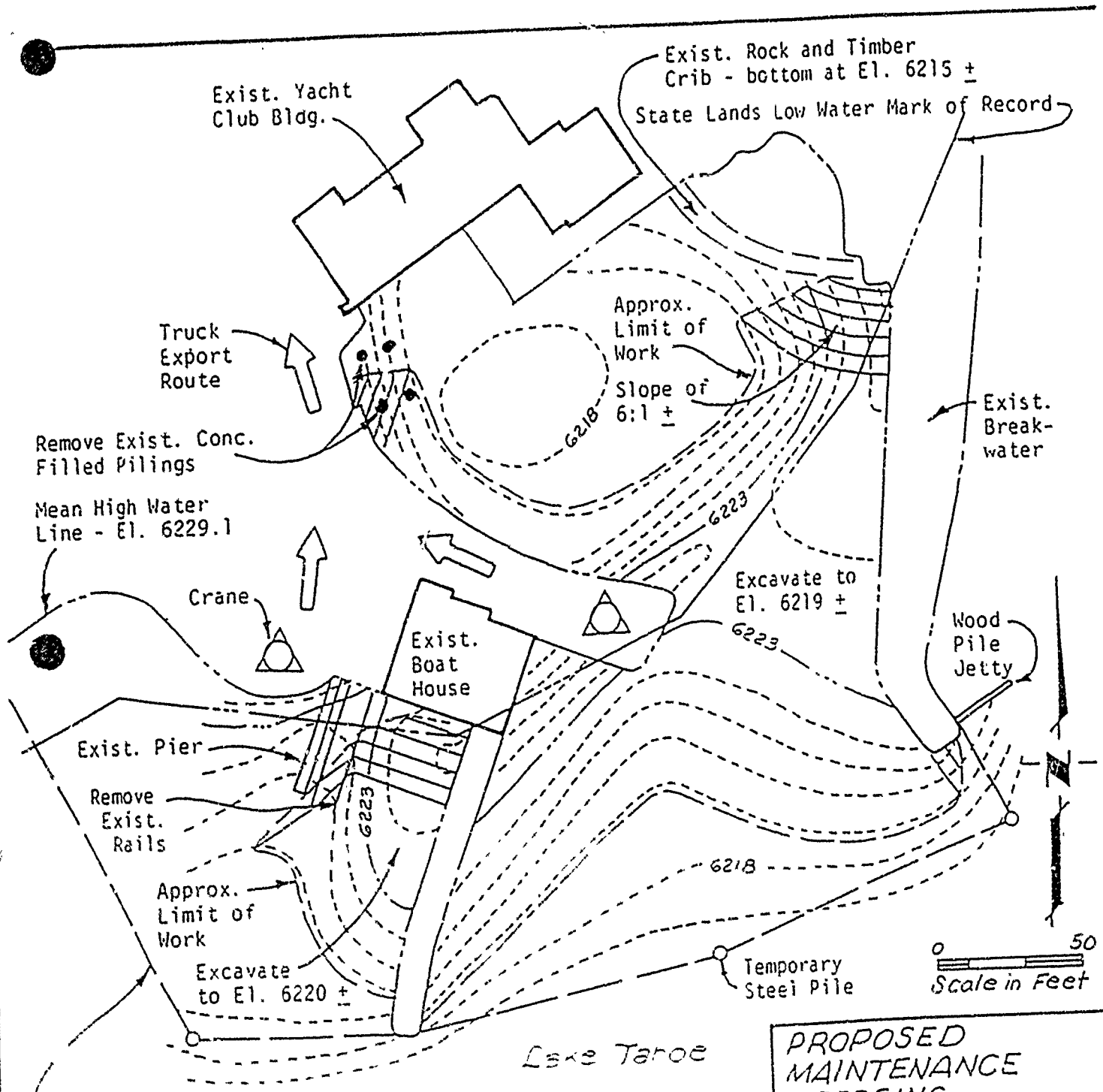

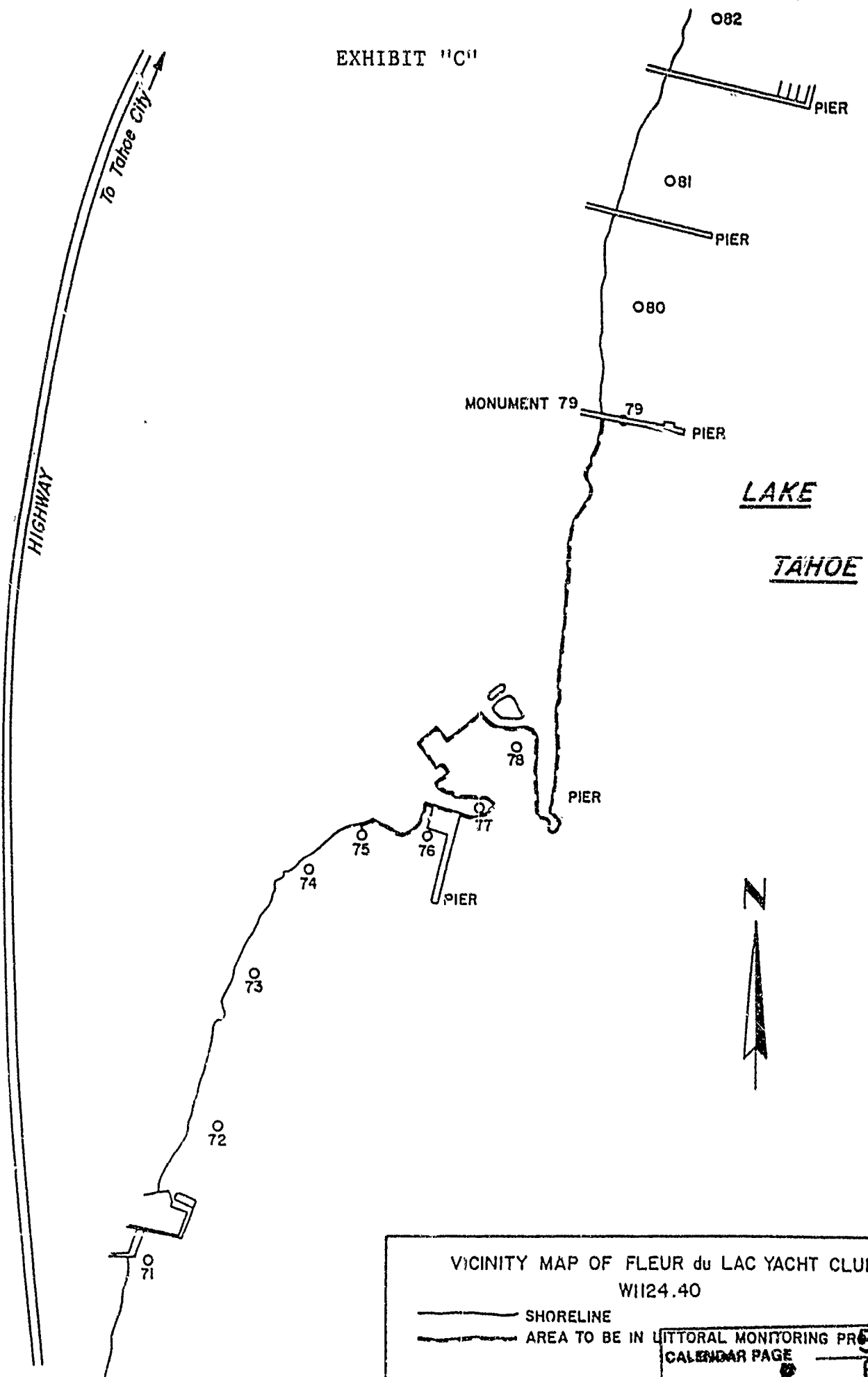
