DEFERMENT OF DRILLING REQUIREMENT, STATE OIL AND GAS LEASE PRC 3095

LESSEE:

Chevron USA, Inc. 575 Market Street

San Francisco, California 94120

AREA, TYPE LAND AND LOCATION:

State Oil and Gas Lease PRC 3095 was issued on January 30, 1964 and contains approximately 3,360 acres of tide and submerged lands lying in the County of Orange. State Lease PRC 3095 is currently being held by Chevron USA, Inc.

SUMMARY:

Resumption of drilling operations from existing facilities on Oil and Gas Lease PRC 3095.1 was authorized by the Commission on January 14, 1975. Under the terms of lease, Chevron is required to maintain a continuing drilling program until the underlying oil and gas reservoirs are fully developed. That program requires that each well drilled or redrilled must be commenced within 120 days after the cessation of drilling operations on the preceding well. An engineering and geologic review indicates that the field may be fully developed except for two shallow zones. Chevron requests a 90 day deferment from the drilling requirement during which to:

1. Re-evaluate the lease geology.

Determine wells which could at some point be plugged back and re-completed in the shallow zones.
