OTHER PERTINENT INFORMATION:

1. In March 1979 and July 1981, the Wildlife Conservation Board acquired the two parcels of upland surrounding that portion of the Lagoon which Fish and Game wishes to manage as a State Wildlife Area.

In order to accomplish the goal of preserving the valuable wetlands, the Department of Fish and Game wishes to obtain the necessary permit covering the tide and submerged portions of San Dieguito Lagoon.

- 2. Future management of the area may require the removal or maintenance of dikes, channels or other water supply and control structures to maintain or enhance wildlife values of the area.
- 3. The annual rental value of the site is estimated to be \$24,000.
- 4. An EIR is not required. This transaction is within the purview of 2 Cal. Adm. Code 2905, Class 7, which exempts permits to public agencies for wildlife preservation activities.

LAND DESCRIPTION

All those state-owned tide and submerged lands in the bed of the south channel of San Dieguito Lagoon, San Diego County, California, lying within the following described parcels:

PARCEL 1

The S-1/2 of the SW-1/4 of Section 12, T14S, R4W, SBM, in the lounty of San Diego, State of California, according to official plat thereof.

Excepting from the above described land those portions thereof described in deeds to the State of California recorded July 17, 1961, as Document No. 121611 and recorded July 21, 1961 as Document No. 125149, both of official records, said portions lying easterly of a line described as follows:
