### MARCH 24, 1983


The regular meeting of the State Lands Commission was called to order by Acting Chairman Peter Pelkofer, representing Kenneth Cory, State Controller at 10:15 a.m. in Rcom 447 of the State Capitol, Sacramento, California.

### CITY OF LONG BEACH - BUSINESS LICENSE TAX

WE HAVE RECEIVED A LETTER FROM THE CITY OF LONG BEACH NOTIFYING US OF THEIR INTENTION TO INCREASE THEIR BUSINESS LICENSE TAX FROM 73¢/BBL TO 12¢/BBL. THEY ARE HOLDING A PUBLIC HEARING ON THE ISSUE ON APRIL 5, 1983.

THIS TAX IS SIMILAR TO A SEVERANCE TAX AND IS LEVIED ON EACH BARREL OF OIL PRODUCED ABOVE 100 BBL/MONTH/WELL THIS TAX IS ALSO COLLECTED ON OIL PRODUCED FROM THE GRANTED TIDELANDS AND TRACT 2 OF THE LONG BEACH UNIT.

THE TAX HAD NO. IMPACT ON THE STATE LONG BEACH TIDELANDS REVENUE PRIOR TO 1979 BECAUSE THE TAXES COLLECTED FROM GRANTED TIDELAND PRODUCTION WERE RECYCLED AS OIL REVENUE AND SPLIT UNDER THE PROVISIONS OF CHAPTER 138. IT WAS OUR UNDERSTANDING THAT THIS WAS PART OF THE COMPROMISE AGREEMENT IN CHAPTER 138. IN 1979, THIS RECYCLING WAS STOPPED AND TAXES ON THE GRANTED TIDELANDS WERE RETAINED BY THE CITY.

FROM 1979 TO DATE THE STATE'S REVENUE HAS BEEN REDUCED BY ABOUT \$6 MILLION DOLLARS, WITH FUTURE REDUCTION UNDER THE CURRENT TAX OF AN ADDITIONAL \$25 MILLION. IF THE TAX IS INCREASED AS PROPOSED, THIS COULD HAVE A FURTHER FUTURE IMPACT ON THE STATE OF AN ADDITIONAL \$15 MILLION

THROUGH THE NET PROFIT ACCOUNTS THE STATE IS CURRENTLY PAYING \$1,400,000/YEAR AND THIS WILL INCREASE TO \$2,240,000/YEAR IF THE TAX IS INCREASED.

### REPORT ON STORM DAMAGE

THE FEBRUARY 28 TO MARCH 1 STORM CAUSED VARYING DEGREES OF DAMAGE TO OIL-PRODUCING FACILITIES ON STATE OIL AND GAS LEASES. A MINIMAL AMOUNT OF OIL WAS SPILLLED DURING THE STORM, AND NO OIL WAS REPORTED TO HAVE REACHED THE BEACHES.

LOSS OF REVENUE FROM ROYALTIES IS ESTIMATED TO BE \$3.2 MILLION FOR THE NEXT 12 MONTHS. IN ADDITION, \$6.3 MILLION OF REPAIRS HAVE BEEN REQUIRED TO REPAIR DAMAGE TO THUMS ISLANDS FREEMAN AND WHITE.

DAMAGE OCCURRED ON THE NORTH SIDE OF ISLAND WHITE AND THE WEST SIDE OF ISLAND FREEMAN. ARMOR ROCK AND PLANTING AREA WERE LOST FOR 350' ON WHITE, AND 450' ON FREEMAN. DAMAGE CARRIED BACK INTO THE WORKING SURFACE ON BOTH ISLANDS. LESSER DAMAGE OCCURRED TO THE REMAINDER OF THE PERIMETER OF THESE TWO ISLANDS, AND TO THE PERIMETER OF GRISSOM AND CHAFFEE. ONE DECORATIVE FORM, A WATERFALL WAS LOST ON WHITE, AND ANOTHER FORM WAS SEVERELY UNDERCUT. REPAIR WORK WAS STARTED IMMEDIATELY, AND IS ESSENTIALLY COMPLETED. NO PRODUCTION WAS LOST.

THE MOST SEVERE DAMAGE OCCURRED AT CHEVRON'S ISLAND ESTHER, WHICH HAS BEEN DESTROYED. THE ISLAND WHICH ORIGINALLY MEASURED 260 x 300 AT THE WATERLINE HAS BEEN REDUCED TO A 60 x 150' WHARF (WHICH IS BADLY DAMAGED) AND 92 EXPOSED WELLHEADS. EXECUTIVE OFFICER'S REPORT -4- MARCH 24, 1983

BATHYMETRIC SURVEYS INDICATE THAT ALL ROCK AND DEBRIS HAVE BEEN SHIFTED NORTHEAST OF THE ORIGINAL ISLAND BY AS MUCH AS 250'. REVENUE FROM THIS LEASE HAS BEEN APPROXIMATELY \$2,500,00 PER YEAR. CHEVRON HAS MOVED IN A LARGE CRANE BARGE AND CEMENTING BOAT, AND HAS BEEN SECURING. THE WELLS UNTIL THE ECONOMIC FEASIBILITY OF RESTORING PRODUCTION HAS BEEN DETERMINED. THE ISLAND WAS CONSTRUCTED FOR A COST OF \$3,500,000 IN 1964/65.

LESS SEVERE DAMAGE OCCURRED IN OTHER AREAS AS FOLLOWS:

1. A 200' SECTION OF THE ARCO-EXXON PIER AT GOLETA WAS DESTROYED. THE PIER WILL BE OUT OF SERVICE FOR OVER 90 DAYS, AND THE LESSEES HAVE SERVED NOTICE THAT A FORCE MAJEURE CONDITION EXISTS. NO PRODUCTION LOSS HAS OCCURRED BECAUSE OF THIS.

2. PLATFORM HOLLY PIPELINES AF GOLETA WERE EXPOSED ON BEACH DURING HEIGHT OF STORM. PLATFORM WAS SHUT IN BECAUSE OF LINE MOVEMENT FOR ONE DAY. LOSS OF REVENUE \$100,000.

3. A ROAD WASHOUT HAS ISOLATED PRC 421 WELLS AT GOLETA. PRODUCTION WILL BE OFF 30 DAYS. ESTIMATED LOSS OF REVENUE \$3,000.

4. APPROACH ROAD TO RINCON ISLAND WASHED OUT. PRODUCTION OF 2 DAYS. LOSS OF REVENUE \$2,600. EXECUTIVE OFFICER'S REPORT -5- MARCH 24, 1983

5. MOBIL/NORRIS PIER HAD A 300' SECTION DESTROYED, AND 200 PILINGS DAMAGED. PARTIAL PRODUCTION LOSS FOR 60 DAYS. ESTIMATED LOSS OF REVENUE \$35,000.

6. EXXON BELMONT ISLAND SUFFERED ELECTRICAL DAMAGE. PRODUCTION WILL BE OFF FOR 60 DANS. LOSS OF REVENUE \$560,000.
