## RENEWAL OF NONCOMMERCIAL LEASE

APPLICANT:

- Island Farms 9990 Santa Monica Boulevard Beverly Hills, California 90212
- AREA, TYPE LAND AND LOCATION: An 0.071-acre parcel of tide and submerged land located in the San Joaquin River at Venice Island, San Joaquin County.
- Maintenance of a floating dock and walkway utilized for recreational boating. LAND USE:

TERMS OF ORIGINAL LEASE: Ten years from July 31, Initial period: 1973.

> One successive period Renewal options: of ten years.

\$1,000. Surety bond:

Public liability insurance: \$100,000 per occurrence for bodily injury and \$25,000 for property damage. \$225 per annum; five-year

Consideration: rent review.

TERNS OF PROPOSED RENEWAL OF LEASE: Initial period: Ten years from July 31, 1983.

Surety bond: \$1,000.

Public liability insurance: Combined single limit coverage of \$800,000 per occurrence for bodily injury and property damage.

CONSIDERATION: \$252 per annum, with the State reserving the right to fix a different rental on each fifth anniversary of the lease.

BASIS FOR CONSIDERATION: Pursuant to 2 Cal, Adm. Code 2003.

PREREQUISITE TERMS, FEES AND EXPENSES: Applicant is owner of upland.

Filing fee has been received.


## EXHIBIT: A. Location Map.

IT IS RECOMMENDED THAT THE COMMISSION:

- 1. DETERMINE THAT AN ENVIRONMENTAL DOCUMENT HAS NOT BEEN PREPARED FOR THIS ACTIVITY AS SUCH DOCUMENT IS NOT REQUIRED UNDER THE PROVISIONS OF P.R.C. 21084, 14 CAL. ADM. CODE 15100 ET SEQ., AND 2 CAL. ADM. CODE 2905; AND FIND THAT THE PROJECT IS CONSISTENT WITH ITS USE CLASSIFICATION.
- 2. AUTHORIZE ISSUANCE TO ISLAND FARMS OF A TEN-YEAR RENEWAL OF NONCOMMERCIAL LEASE PRC 2212.1 FROM JULY 31, 1983, IN CONSIDERATION OF ANNUAL RENT IN THE AMOUNT OF \$252, WITH THE STATE RESERVING THE RIGHT TO FIX A DIFFERENT RENTAL ON EACH FIFTH ANNIVERSARY OF THE LEASE; WITH PROVISION OF A \$1,000 SURETY BOND; AND WITH PROVISION OF COMBINED SINGLE LIMIT PUBLIC LIABILITY INSURANCE COVERAGE IN THE AMOUNT OF \$800,000 PER OCCURRENCE FOR BODILY INJURY AND PROPERTY DAMAGE; FOR A FLOATING DOCK AND WALKWAY ON THE LAND DESCRIBED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.
