AMERICAN TELEPHONE AND TELEGRAPH COMMUNICATIONS COMPANY HAS SUBMITTED AN APPLICATION TO INSTALL A TRANSCONTINENTAL CABLE OVER THE PRESENT AND HISTORIC CHANNELS OF THE COLORADO RIVER. THE WORK IS PART OF A LARGER PROJECT AND THE APPLICANT HAS ASKED FOR ADVANCE PERMISSION TO BEGIN WORK SCHEDULED FOR MARCH 1, 1985; AND THERE IS INSUFFICIENT TIME TO PROCESS THE APPLICATION. ALSO, LAND TITLES ARE COMPLEX IN THIS AREA, AND CANNOT BE RESOLVED WITHOUT EXTENSIVE INVESTIGATION, WHICH HAS BEEN STARTED.

I HAVE ISSUED A LETTER OF ADVANCE PERMISSION TO THE COMPANY FOR THIS PROJECT, AND THE APPLICANT IS FULLY COOPERATING WITH THE STAFF.

THE APPLICANT IS OBTAINING CLEARANCES FROM OTHER JURISDICTIONS, AND THERE ARE NO ENVIRONMENTAL CONCERNS OVER THE PROJECT.
