EMERGENCY LETTER OF PERMISSION - ST. MALO BEACH ASSOC. SD 85-07-25

BY LETTER DATED AUGUST 14, 1985, STAFF OF THE COMMISSION GRANTED PERMISSION TO THE ST. MALO BEACH ASSOCIATION TO PERFORM EMERGENCY WORK ON LANDS OWNED BY THE STATE IN BUENA VISTA LAGOON, SAN DIEGO COUNTY. TO ATTEMPT CONTROL OF THE MOSQUITO POPULATION PLAGUING THE LAGOON AND NEIGHBORING RESIDENTIAL AREA, THE ASSOCIATION WILL USE A MECHANICAL WEED HARVESTER TO REMOVE 75% OF THE AQUATIC PLANTS WHICH ENCIRCLE THE ST. MALO PORTION OF THE LAGOON SHORELINE. THE PERMITTED WORK DOES NOT INCLUDE THE USE OF HERBICIDES OR CHEMICALS OF ANY KIND. THE LETTER OF PERMISSION IS SOLELY FOR THE REMOVAL OF VEGETATION. THE ASSOCIATION HAS BEEN NOTIFIED BY STAFF THAT ANY CONTINUAL MAINTENANCE PROGRAM WILL BE SUBJECT TO THE PERMITTING REQUIREMENTS OF THE STATE LANDS COMMISSION. STAFF OF THE COASTAL COMMISSION, DEPARTMENT OF FISH AND GAME, AND SAN DIEGO COUNTY HEALTH DEPARTMENT HAVE APPROVED THE PROJECT.

TEMPORARY PERMIT - LOS ANGELES COUNTY FLOOD CONTROL DISTRICT
W 23506 PRC 6888

MR. WILL DANIEL OF THE LOS ANGELES COUNTY FLOOD CONTROL DISTRICT HAS REQUESTED ISSUANCE OF A TEMPORARY PERMIT, WHILE THE REGULAR PERMIT APPLICATION IS BEING PROCESSED, TO ALLOW THE PLACEMENT OF SEDIMENTS FROM EROSION CONTROL FACILITIES ON TIDE AND SUBMERGED LANDS AT TOPANGA STATE BEACH FOR DISPERSION BY OCEAN WAVE ACTION, THE USE AREA WOULD BE BETWEEN THE CHARHOUSE RESTAURANT AND WILL ROGERS STATE BEACH. A NEGATIVE DECLARATION HAS BEEN CIRCULATED FOR THIS PROJECT.

THE DEPARTMENT OF PARKS AND RECREATION HAS APPROVED A PERMIT FOR THIS WORK BEGINNING SEPTEMBER 3, 1985.

WITH THE COMMISSION'S CONCURRENCE, I WILL ISSUE A SIX-MONTH TEMPORARY PERMIT WHICH SHALL BE CONDITIONED UPON PERMIT APPROVALS BY OTHER GOVERNMENTAL AGENCIES HAVING JURISDICTION, INCLUDING, BUT NOT LIMITED TO, THE COASTAL COMMISSION AND THE CORPS OF ENGINEERS AND WHICH WILL ALLOW STAFF TIME TO PROCESS A FORMAL PERMIT IN A NORMAL MANNER.
